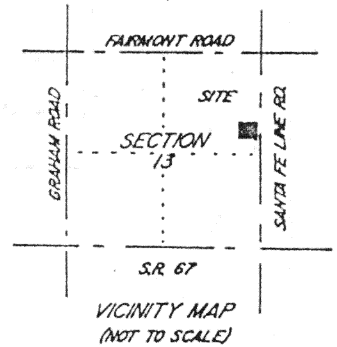


PLAT OF A SURVEY  
IN THE N.E. 1/4 OF  
SECTION 13, T-5-S, R-7-E  
UNION TOWNSHIP  
AUGLAIZE COUNTY, OHIO

SURVEY MADE FOR R. ANTHONY  
5/18/90



Being a parcel of land situated in the northeast 1/4 of section 13, Township 5 south, Range 7 east, Union Township, Auglaize County, Ohio, and being part of the lands described in O.R. vol. 100, pg. 573, more particularly described as follows:

Beginning at a railroad spike set on the east line of section 13 and in Township Rd. 251 (Santa Fe Line Rd.), this point being 1967.63 feet south of a monument box found for the northeast corner of section 13;

(1) Thence South, along the east line of section 13 and in Township Rd. 251 (Santa Fe Line Rd.), for 362.00 feet to a railroad spike set-

(2) Thence West for 362.00 feet to a 5/8" iron pin set, passing at 20.00 feet a 5/8" iron pin set-

(3) Thence North for 362.00 feet to a 5/8" iron pin set-

(4) Thence East for 362.00 feet to the point of beginning, passing at 342.00 feet a 5/8" iron pin set.

Containing in all 3.008 acres of land, subject however to all legal easements and rights of way.

Note: This plat and description prepared from an actual field survey, all bearings refer to the east line of section 13 as being South.
