LEGAL DESCRIPTION

Myers and Carolyn M. Myers (Deed Volume 237, Page 288) extended and the POINT OF BEGINNING; thence continuing southerly with said centerline at S 00°57′53"W, 14.91 feet to a railroad spike (found) at an angle point in said centerline at ODOT Station 550+89.84; thence continuing southerly with said centerline at S 00°46'49"E, 218.00 feet to a mine spike (set); thence westerly into said Outlot 8 at N 89°39'10"W, 338.15 feet to a 3/4-inch iron pipe (set) (this course passes a 3/4-inch iron pipe (set) in the west right-of-way line of State Route 65 at 33.01 feet); thence northerly within said Outlot 8, through said Outlot 7 and into said Outlot 6, at N 00°46′45″E, 358.64 feet to a concrete monument (found) at the southwest corner of the St. Johns United Methodist Church property; thence easterly with the south lines of lands granted to the St. Johns United Methodist Church (Vol. 262, Page 379) and the Board of Trustees of Union Township (Vol. 260, Page 649) at S 89°12'22"E, 142.83 feet to a 1/2-inch iron rod (found) at the northwest corner of said Myers parcel; thence southerly with the west line of said Myers parcel S 00°56'08"W, 124.66 feet to a 1/2-inch iron rod (found) at the southwest corner of said Myers parcel; thence easterly with the south line of said Myers parcel at S 89°39'10"E, 189.77 feet to the POINT OF BEGINNING (this course passes a 1/2-inch iron rod (found) in the west right-of-way line of State Route 65 at 157.00 feet).
