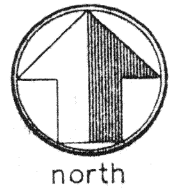
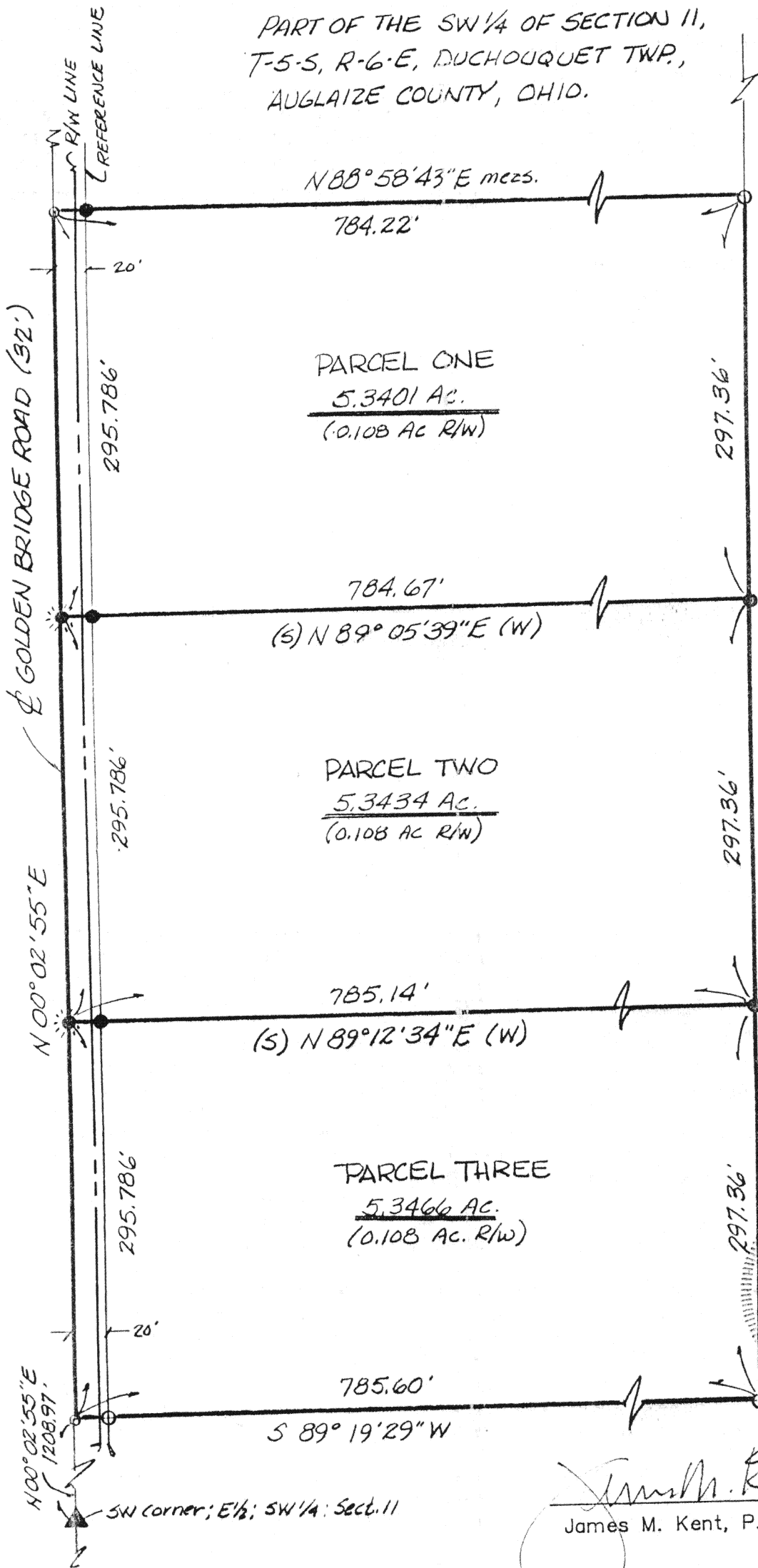
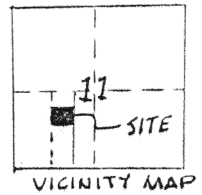


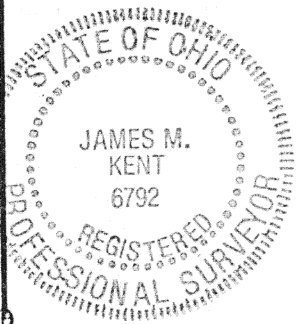
PART OF THE SW 1/4 OF SECTION 11,

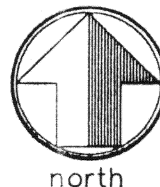

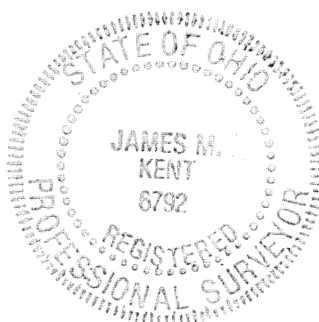
