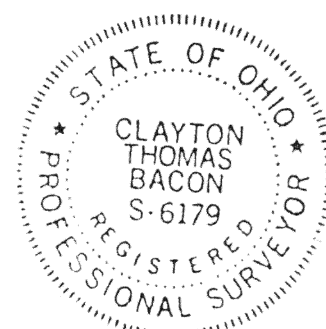

#### DESCRIPTION

Being a parcel of land in the SW $\frac{1}{4}$  of Section 11, Duchouquet Township, T5S, R6E, Auglaize County, Ohio, more particularly described as follows:

Beginning at an existing mine spike on the centerline of Golden Bridge Rd. (west line of the E $\frac{1}{4}$  of the SW $\frac{1}{4}$  of Sec. 11) N.0°-02'-55"E (assumed bearing), 544.00' from the monument box as the southwest corner of the E $\frac{1}{4}$  of the SW $\frac{1}{4}$  of Section 11, thence the following courses;

1. Continue N.0°-02'-55"E. on the road centerline, 664.97' to a set PK nail;
2. N.89°-19'-29"E., 785.60' to a set #5 rebar, passing over a set #5 rebar at 20.00';
3. S.0°-02'-41"E., 664.96' to an existing #5 rebar;
4. S.89°-19'-29"W., 786.68' to the POINT OF BEGINNING.

The above described parcel contains 12.000 acres, more or less, subject to all legal highways and easements of record.
