LEGAL DESCRIPTION

Being a part of the northeast quarter of the southeast quarter of Section 27, T-5-S, R-6-E, Duchouquet Township, Auglaize County, Ohio as evidenced by Deed Volume O.R. 26, Page 229, and being more particularly described as follows:

Commencing at a point in the northwest corner of the northeast quarter of the southeast quarter of Section 27; thence east along the north line of said northeast quarter of the southeast of said Section 27 a distance of 627 feet to the northwest corner of a tract of land evidenced by O.R. 10, Page 283; thence S 00°41/22"E along the west line of the aforesaid tract, a distance of 37.46 feet to a 5/8" re-rod w/cap (set) and the PLACE OF BEGINNING;

thence continuing S 00°41'22"E a distance of 47.06 feet to a 5/8" re-rod w/cap (set);

thence N $81^{\circ}46'34''W$ a distance of 16.62 feet to a 5/8'' re-rod w/cap (set);

thence N $08^{\circ}13'25"E$ a distance of 46.49 feet to a 5/8" re-rod w/cap (set);

thence S 81°46'34"E a distance of 9.33 feet to the PLACE OF BEGINNING, containing therein 603.3 square feet, or 0.014 acres more or less.
