

Being part of Lot 109 in Meadowbrook Place No. 2, in the northwest % of Section 34, Township 4 South, Range 6 East, Duchouquet Township, Auglaize County, Ohio and being more particularly described as follows:

Beginning for the same at an iron pin found marking the southwest corner of Lot 109 $-\,$

Thence north $19^\circ-00'-00"$ east, along the west line of Lot 109 for a distance of 64.00 feet to a 5/8 inch iron pin set -

Thence south $71^{\circ}-00'-00"$ east, for a distance of 114.91 feet to a 5/8 inch iron pin set -

Thence south $26^{\circ}-00'-00"$ west, along the west line of Hansom Lane, for a distance of 22.25 feet to an iron pin found -

Thence south $88^{\circ}-30'-50"$ west, along the south line of Lot 109, for a distance of 119.77 feet to the point of beginning.

Containing 4859 square feet or 0.112 acres of land, subject, however to all legal easements and rights-of-way.

Note: All bearings refer to the south line of Lot 109 as being south $88\,^{\circ}-30\,^{\prime}-50\,^{\prime\prime}$ west.
