



DESCRIPTION

scale:

Being a parcel of land situate in the Southeast Quarter of Section 31, T-5-S, R-5-E, Moulton Township, Auglaize County, Ohio and more particularly described as follows:

Commencing at a monument box found at the southeast corner of said Southeast Quarter of said Section 31; thence with the centerline of Glynwood - New Knoxville Road and the east line of said Southeast Quarter of Section 31, N 02 degrees 05' 35" E for a distance of 712.67 feet to a cotton gin spindle (set) and the PLACE OF BEGINNING;

thence N 89 degrees 13' 35" W (passing through a pinch pipe found on the westerly line of a highway easement as evidenced by Deed Volume 213, Pg. 696, at a distance of 41.98 feet) for a total distance of 420.00 feet to a 5/8" re-rod w/cap (set);

. thence N 02 degrees 05' 35" E for a distance of 849.48 feet to a 5/8" re-rod w/cap (set);

thence N 85 degrees 50' 11" E, parallel with and 50 feet south of a portion of the southerly limited access boundary line of U. S. Route 33, (passing through a 5/8" re-rod w/cap set on the westerly line of the aforesaid highway easement line at a distance of 291.66 feet) for a total distance of 422.41 feet to a cotton gin spindle (set) on the centerline of Glynwood - New Knoxville Road and the east line of the Southeast Quarter of Section 31;

thence S 02 degrees 05' 35" W along said east line and centerline for a distance of 554.31 feet to a pk nail (found);

thence N 89 degrees 13' 35" W (passing through a 5/8" re-rod found at a distance of 75.35 feet, on the westerly line of the aforesaid highway easement) for a total distance of 400.00 feet to a 5/8" re-rod (found);

thence S 02 degrees 05' 35" W for a distance of 131.53 feet to a 5/8" re-rod (found);

thence S 89 degrees 13' 35" E (passing the westerly line of the aforesaid highway easement at a distance of 337.89 feet) for a total distance of 400.00 feet to the centerline of Glynwood - New Knoxville Road and the east line of the Southeast Quarter of Section 31;

thence S 02 degrees 05' 35" W along said centerline and east line, for a distance of 200.00 feet to the PLACE OF BEGINNING, containing therein 7.156 acres, of which, 1.536 acres is highway easement.
