
LOCATION SKETCH



ZWIEBEL SURVEY DESCRIPTION

Being a parcel of land situated in Moulton Township, Auglaize County, Ohio, in the northwest quarter of the southwest quarter of Section 31, Township 5 South, Range 5 East. Being more particularly described as follows:

Commencing for reference at an iron bar in a monument box at the southwest corner of the northwest quarter of the southwest quarter of said Section 31-

Thence, north 01°19'05" east, along the west line of the northwest quarter of the southwest quarter of said Section 31 and the centerline of County Road 71, a distance of two hundred fifty-four and 78/100 (254.78) feet to a mine spike. Said point being the place of beginning for the parcel to be conveyed by this instrument-

Thence, continuing, north 01°19'05" east, along the last described line, a distance of three hundred forty-one and 63/100 (341.63) feet to a mine spike-

Thence, south 88°57'49" east, a distance of one thousand eighty and 34/100 (1080.34) feet to a 5/8 inch iron bar-

Thence, south 01°19'05" west, a distance of three hundred thirty-two and 74/100 (332.74) feet to a 5/8 inch iron bar in the north line of a 8.56 acre tract of land as surveyed by Clayton H. Stimmel on July 14, 1972-

Thence, north 88°26'06" west, along said north line of an 8.56 acre tract of land, a distance of one thousand eighty and 43/100 (1080.43) feet to the place of beginning.

Containing 8.362 acres of land more or less.

Subject to all easements and right-of-way of record.
