



LEGAL DESCRIPTION

Parcel One

scale

Being a part of the South half of the Southwest Quarter of Section 33, T-5-S, R-4-E, Noble Township, Auglaize County, Ohio and more particularly described as follows:

Commencing at a fence post at the center of said Section 33; thence S 01 degrees 23' 42" W for a distance of 1325.68 feet to an iron pin (found) at the Northeast corner of the Southeast quarter of the Southwest quarter of Section 33; thence N 88 degrees 51' 50" W along the North line of the Southeast quarter of the Southwest quarter of said Section 33, for a distance of 778.69 feet to an iron pin w/cap (found) and the PLACE OF BEGINNING,

thence S 01 degrees 59' 45" W, for a distance of 1,322.57 feet to a railroad spike (found) on the centerline of Indiana Avenue (State Route 29);

thence N 50 degrees 08' 11" W along said centerline for a distance of 429.24 feet to a point at the limited access right-of-way line of said SR 29 and the corporate limits of the City of St. Marys;

thence with the following courses along said limited access right-of-way line and corporate limits;

N 39 degrees 51' 49" E - 135.00 feet;

N 50 degrees 08' 11" W - 520.00 feet;

N 39 degrees 54' 02" W - 365.82 feet;

N 39 degrees 51' 52" E - 260.00 feet;

N 76 degrees 36' 01" E - 575.65 feet to a 5/8" re-rod w/cap (set);

thence leaving said limited access right-of-way line and corporate limits on a bearing of S 88 degrees 51' 50" E for a distance of 196.21 feet to the PLACE OF BEGINNING, containing therein 15.646 acres, of which 1.167 acres is public right-of-way. Subject to easements and restrictions of record. Permanent markers shall be set at all corners upon completion of the proposed subdivision of the parcel described herein.

Parcel Two

Being a part of the Southwest quarter of Section 33 and a part of Lot 3 of Buhler's Subdivision of a part of the Southeast quarter of Section 33, T-5-S, R-4-E, Noble Township, Auglaize County, Ohio and more particularly described as follows:

Commencing at a corner post marking the center of said Section 33; thence S 01 degrees 23' 42" W for a distance of 1,325.68 feet to an iron pin (found) at the Northeast corner of the Southeast quarter of the Southwest quarter of Section 33 and the PLACE OF BEGINNING,

thence S 88 degrees 57' 26" E along the North line of the Southwest quarter of the Southeast quarter for a distance of 664.37 feet to a re-rod (found);

thence N 01 degree 22' 53" E for a distance of 164.46 feet to a re-rod (found) on the southerly limited access right-of-way line of U.S. Route 33;

thence S 89 degrees 38' 06" W along said limited access right-of-way line for a distance of 418.92 feet to a 5/8" re-rod (found);

thence S 84 degrees 49' 08" W along said limited access right-of-way line for a distance of 1,097.50 feet to a point on the lid of a Midwest Electric manhole (see plat of survey by Kenflorth Surveying, drawing # 1046, dated 3/22/90 for reference to corner);

thence S 76 degrees 36' 01"W along said limited access right-of-way line for a distance of 134.67 feet to a 5/8" re-rod (found);

thence S 88 degrees 51' 50" E (passing through a re-rod w/cap found at the Northeast corner of Parcel One described herein at a distance of 196.21 feet) for a total distance of 974.90 feet to the PLACE OF BEGINNING, containing therein 3.938 acres and subject to easements, rights-ofway and restrictions of record.
