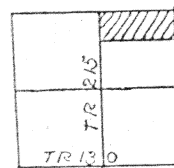

DESCRIPTION
PARCEL NO. 1

Being a parcel of land situate in the north half of the Northeast quarter of Section 4, T-6-S, R-7-E, Clay Township, Auglaize County, Ohio and more particularly described as follows:

BEGINNING at a ODOT concrete monument found at the northwest corner of said Northeast quarter of said Section 4; thence S 89°59'07" E with the north line of said Northeast quarter, 1,460.33 feet to a 5/8 inch rebar set; thence S 00°45'42" E, 455.02 feet to a 5/8 inch rebar set; thence N 87°53'56" E, 589.82 feet to a 5/8 inch rebar set; thence N 00°35'58" E, 433.22 feet to a 5/8 inch rebar set on the north line of said Northeast quarter of said Section 4; thence S 89°59'07" E with said north line, 398.60 feet to an iron pin found at the southeast corner of the Southeast quarter of Section 33, T-5-S, R-7-E, Union Township; thence S 89°11'40" E continuing with the north line of said Northeast quarter of said Section 4, 203.45 feet to an railroad spike at the northeast corner of said Northeast quarter; thence S 00°35'58" W with the east line of said Northeast quarter, 653.44 feet to a 5/8 inch rebar set; thence N 89°55'29" W, 2,660.26 feet to a railroad spike set on the west line of said Northeast quarter of said Section 4; thence N 00°24'53" E with said west line, 653.43 feet to the PLACE OF BEGINNING containing 33.937 acres more or less and subject to all highway and other legal easements of record.

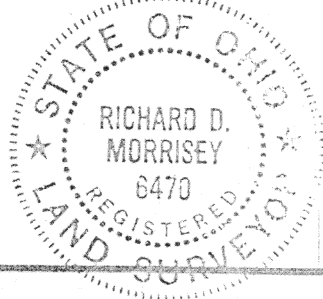
