LAMAN SURVEY DESCRIPTION

Being a parcel of land situated in Noble Township, Auglaize County, Ohio, in the northeast quarter of Section 16, Township 5 South, Range 4 East. Being more particularly described as follows:

Commencing for reference at an iron bar in a monument box at the center of said Section 16-

Thence, south 89°48'54" east, along the south line of the northeast quarter of said Section 16 and the centerline of Arnold Road, a distance of one hundred fifty (150.00) feet to a 5/8 inch iron bar. Said point being the place of beginning for the parcel to be conveyed by this instrument-

Thence, continuing, south 89°48'54" east, along the last described line, a distance of one hundred fifty (150.00) feet to a 5/8 inch iron bar-

Thence, north, a distance of two hundred ninety and 40/100 (290.40) feet to a 5/8 inch iron bar-

Thence, north 89°48'54" west, a distance of one hundred fifty (150.00) feet to a 5/8 inch iron bar-

Thence, south, a distance of two hundred ninety and 40/100 (290.40) feet to the place of beginning.

Containing 1.000 acre of land more or less.

Subject to all easements and right-of-way of record.
