

## DESCRIPTION - PARCEL NO. 1


Being a parcel of land situate in the south half of the Southwest quarter of Section 6, T-7-S, R-4-E, German Township, Auglaize County, Ohio and more particulalry described as follows:

Commencing at an iron pin found in a monument box at the southeast corner of said Southwest quarter of said Section 6; thence N°89°47'45" W with the south line of said Southwest quarter (also the centerline of Lock Two Road), 1010.56 feet to a PK nail found and the PLACE OF BEGINNING; thence continuing N 89°47'45" W with said south line and centerline, 210.00 feet to a PK nail set; thence N 00°12'15" E (passing through a 5/8 inch rebar set at 25.00 feet), 233.00 feet to a 5/8 inch rebar set; thence S 89°47'45" E (passing through a 5/8 inch rebar found at the top of the bank of an existing creek at 193.85 feet), 210.32 feet to the centerline of said creek; thence S 00°17'00" W with said centerline of said creek and the projection of said centerline (passing through a 5/8 inch rebar found at 208.00 feet), 233.00 feet to the PLACE OF BEGINNING containing 1.124 acres more or less and subject to all highway and other legal easements of record.

Commencing at an iron pin found in a monument box at the southeast corner of said Southwest quarter of said Section 6; thence N 89°47'45" W with the south line of said Southwest quarter (also the centerline of Lock Two Road), 1220.56 feet to a PK nail set and the PLACE OF BEGINNING; thence continuing N 89°47'45" W with said south line and centerline, 210.00 feet to a PK nail set; thence N 00°12'15" E (passing through a 5/8 inch rebar set at 25.00 feet), 233.00 feet to a 5/8 inch rebar set; thence S 89°47'45" E, 210.00 feet to a 5/8 inch rebar set; thence S 00°12'15" W (passing through a 5/8 inch rebar set at 208.00 feet), 233.00 feet to the PLACE OF BEGINNING containing 1.123 acres more or less and subject to all highway and other legal easements of record.
