



## SURVEYOR'S DESCRIPTION

The following described tract of land is part of the Southeast Quarter of Fractional Section 6, Town 5 South, Range 6 East, Duchouquet Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a R.R. spike found at the Southwest corner of the South east Quarter of Section 6, Duchouquet Township and in the centerline of County Road 190 (Buckland - Holden Road):

thence with an assumed bearing of N.89°30'00"E. along the centerline of County Road 190 and the South line of the Southeast Quarter of Section 6, a distance of 346.10 feet to a P.K. nail set, which is the PLACE OF BEGINNING for the tract of land herein described;

thence N.01°38'37"W. along the centerline of an open ditch, a distance of 146.13 feet to a point;

thence N.09°11'09"W. along the centerline of an open ditch, a distance of 176.95 feet to a point;

thence N.25°39'19"W. along the centerline of an open ditch, a distance of 111.58 feet to a point;

thence N.11°04'30"W. along the centerline of an open ditch, a distance of 74.64 feet to a point;

thence N.28°07'55"E. along the centerline of an open ditch, a distance of 131.46 feet to a point;

thence N.57°40'19"E. along the centerline of an open ditch, a distance of 32.16 feet to a point;

thence N.23°57'03"E. along the centerline of an open ditch, a distance of 148.50 feet to a point;

thence N.02°58'29"E. along the centerline of an open ditch, a distance of 21.97 feet to a point;

thence N.89°30'00"E., parallel to the centerline of County Road 190 and the South line of the Southeast Quarter of Section 6, a distance of 472.01 feet to an iron pin set, passing thru an iron pin set for reference at 20.00 feet on the East bank of an open ditch;

thence S.00°30'00"E. a distance of 784.86 feet to a R.R. spine set, passing thru an iron pin set for reference at 759.86 feet in the North right-of-way line of County Road 190;

thence S.89°30'00"W. along the centerline of County Road 190 and the South line of the Southeast Quarter of Section 6, a distance of 534.36 feet to the P.K. nail which was the true PLACE OF BEGINNING.

Containing in all 10.00 acre of which 0.31 acre has been dedicated for highway purposes. The above described tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Volume OR 213, page 367 and OR 222, page 190 - 192. This plat and description was prepared by John W.
