



## SURVEYOR'S DESCRIPTION FOR PARCEL NO. 1

The following described tract of land is part of Lot No. 1 of the Re-Plat of Out Lots of the Frank Jones Addition and part of O.L. No. 54, Ayers Second Addition to the City of Wapakoneta, part of the Southwest Quarter of Section 28 and part of the Southeast Quarter of Section 29, Town 5 South, Range 6 East, Duchouquet Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a concrete monument found at the intersection of the Northerly right-ofway line of North Wood Street (Dixie Highway) and the East line of Section 29, Town 5 South, Range 6 East, Duchouquet Township;

thence N.46°15'00"E. along the Northerly right-of-way line of North Wood Street (Dixie Highway), a distance of 112.35 feet to a P.K. nail set, which is the PLACE OF BEGINNING for the tract of land herein described;

thence N.43°42'08"W. along the Easterly line of a 20 foot easement as described in Deed Volume O.R. 224, page 76, a distance of 243.14 feet to an iron pin set.

thence N.38°48'56"E. a distance of 128.20 feet to an iron pin found;

thence S.01°03'00"E. a distance of 80.00 feet to an iron pin found;

thence S.43°45'00"E. a distance of 240.94 feet to a point, passing thru an iron pin found at 200.94 feet in the Northerly right-of-way line of North Wood Street (Dixie Highway);

thence S.46°15'00"W. along the tangent centerline of North Wood Street (Dixie Highway) a distance of 73.11 feet to a point;

thence N.43°42'08"W. along the Easterly line of a 20 foot easement, a distance of 40.00 feet to the P.K. nail, which was the true PLACE OF BEGINNING.

Containing in all 0.514 acre of which 0.067 acre has been dedicated for highway purposes. The PLACE OF BEGINNING is at a concrete monument found at the intersection of the Northerly right-of-way line of North Wood Street (Dixie Highway) and the East line of Section 29, Town 5 South, Range 6 East, Duchouquet Township;

thence N.46°15'00"E. along the Northerly right-of-way line of North Wood Street (Dixie Highway), a distance of 23.25 feet to a concrete monument found;

thence N.45°22'10"W. a distance of 230.73 feet to an iron pin found;

thence N.38°48'56"E. a distance of 96.63 feet to an iron pin set;

thence S.43°42'08"E., along the Easterly line of a 20 foot easement as described in Deed Volume O.R. 224, page 76, a distance of 283.14 feet to a point, passing thru a P.K. nail set for reference at 243.14 feet in the Northerly right-of-way line of North Wood Street (Dixie Highway);

thence S.46°15'00"W. along the tangent centerline of North Wood Street (Dixie Highway) a distance of 149.23 feet to a point;

thence N.01°03'00"W. a distance of 54.42 feet to the concrete monument which was the true PLACE OF BEGINNING.:
