

## SURVEYOR'S DESCRIPTION FOR 2.40 ACRE TRACT

The following described tract of land is part of the Northwest Quarter of the Northeast Quarter of Section 3, Town 5 South, Range 4 East, Salem Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a P.K. nail found at the intersection of the centerlines of County Road 200 (Barber - Werner Road) and Township Road 47 (Seibert Road), said P.K. nail being the Northeast corner of the Northwest Quarter of the Northeast Quarter of Section 3, Salem Township;

thence with an assumed bearing of S.00°30'00"E. along the centerline of Township Road 47 and the East line of the Northwest Quarter of the Northeast Quarter, a distance of 146.40 feet

to a P.K. nail set, which is the PLACE OF BEGINNING for the tract of land herein described; thence continuing S.00°30'00"E. along the above described line, a distance of 499.49 feet to a R.R. spike set;

thence S.89°30'00"W. a distance of 30.00 feet to an iron pin set in the West right-of-way line of Township Road 47;

thence N.74°59'09"W. along the centerline of the Warman open ditch, a distance of 116.83 feet to a point;

thence N.43°56'55"W. along the centerline of the Warman open ditch, a distance of 114.55 feet to a point;

thence N.22°27'46"W. along the centerline of the Warman open ditch, a distance of 147.26 feet to a point;

thence N.29°12'59"W. along the centerline of the Warman open ditch, a distance of 120.45 feet to a point;

thence N.00°32'47"W. along the centerline of the Warman open ditch, a distance of 26.63 feet to a point;

thence N.86°45'25"E. along the centerline of the Warman open ditch, a distance of 131.10 feet to a point;

thence N.65°46'45"E. along the centerline of the Warman open ditch, a distance of 120.86 feet to a point;

thence N.56°00'41"E. along the centerline of the Warman open ditch, a distance of 111.18 feet to the P.K. nail which was the PLACE OF BEGINNING.

Containing in all 2.40 acre of which 0.34 acre has been dedicated for highway purposes. The above described tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Volume OR 71, page 230.
