



## SURVEYOR'S DESCRIPTION

The following described tract of land is part of the West half of the Southeast Quarter of Section 34, Town 6 South, Range 4 East, St. Marys Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a monument box found at the Southwest corner of the Southeast Quarter of Section 34, St. Marys Township and is the centerline of Township Road 80 (Clover Four Road);

thence N.89°54'37"E. along the South line of the Southeast Quarter of Section 34, and the centerline of Township Road 80, a distance of 1,005.09 feet to a P.K. nail set, which is the PLACE OF BEGINNING for the tract of land herein described;

thence N.00°23'32"E. a distance of 1,175.00 feet to an iron pin set;

thence N.89°54'37"E., parallel to the South line of the Southeast Quarter of Section 34 and the centerline of Township Road 80, a distance of 282.00 feet to an iron pin set;

thence S.00°23'32"W, a distance of 236.00 feet to an iron pin set;

thence S.89°54'37"W., parallel to the South line of the Southeast Quarter of Section 34 and the centerline of Township Road 80, a distance of 232.00 feet to an iron pin set;

thence S.00°23'32"W. a distance of 939.00 feet to a P.K. nail set;

thence S.89°54'37"W. along the centerline of Township Road 80 and the South line of the Southeast Quarter of Section 34, a distance of 50.00 feet to the P.K. nail, which was the true PLACE OF BEGINNING.

Containing in all 2.60 acre of which 0.03 acre has been dedicated for highway purposes. ## DESCRIPTION FOR 20 FOOT EASEMENT

thence N.89°54'37"E. along the South line of the Southeast Quarter of Section 34, and the centerline of Township Road 80, a distance of 985.09 feet to a point which is the PLACE OF BEGINNING for the tract of land herein described;

thence N.00°23'32"E. a distance of 1,175.00 feet to a point;

thence N.89°54'37"E., parallel to the South line of the Southeast Quarter of Section 34 and the centerline of Township Road 80, a distance of 20.00 feet to an iron pin set;

thence S.00°23'32"W. a distance of 1,175.00 feet to a P.K. nail set;

thence S.89°54'37"W. along the centerline of Township Road 80 and the South line of the Southeast Quarter of Section 34, a distance of 20.00 feet to the point which was the true PLACE OF BEGINNING.

Containing in all 0.54 acre of which 0.01 acre has been dedicated for highway purposes. The above described tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Volume 151, page 323.
