

SURVEYOR'S DESCRIPTION FOR 3.000 ACRE PARCEL

thence S.89°18'02"E. along the South line of the Southwest Quarter of Section 32, a distance of 330.00 feet to an iron pin set, which is the PLACE OF BEGINNING for the tract of land herein described;

thence N.02°05'35"E. a distance of 341.91 feet to an iron pin set;

thence S.89°18'02"E., parallel to the South line of the Southwest Quarter of Section 32, a distance of 377.65 feet to an iron pin set;

thence S.00°31'32"W. a distance of 341.81 feet to a point, passing thru an iron pin set for reference at 315.56 feet in the Northerly Right-of-Way line of County Road 33-A;

thence N.89°18'02"W., along the South line of the Southwest Quarter of Section 32, a distance of 387.00 feet to the iron pin, passing thru an iron pin set for reference at 160.46 feet in the Northerly Right-of-Way line of County Road 33-A, said iron pin was the true PLACE OF BEGINNING.

thence continuing N.02°05;35"E. a distance of 197.29 feet to an iron pin set;

thence S.89°18'02"E., parallel to the South line of the Southwest Quarter of Section 32, a distance of 372.25 feet to an iron pin found;

thence S.00°31'32"W. a distance of 197.23 feet to an iron pin set;
