

SURVEYOR'S DESCRIPTION FOR PARCEL NO. 1



The following described tract of land is part of the Northeast Quarter of Section 22, Town 5 South, Range 6 East, Duchouquet Township, Auglaize County, Ohio and is more particularly described as follows:

The PLACE OF BEGINNING is at an iron pipe found at the Northeast Corner of Lot No. 3 of the Thuman's Subdivision as recorded in Plat Book "B", page 114 in the Auglaize County Recorder's Office;

thence N.66°28'00"E. along the North line of the Thuman Subdivision, a distance of 27.39 feet to an iron pin set;

thence S.00°17'11"W.a distance of 229.72 feet to a point in the centerline of State Route 67, passing thru an iron pin set for reference at 196.92 feet in the Northerly Right-of-Way line

thence S.66°30'00"W. along the centerline of State Route 67, a distance of 27.44 feet to a point;

thence N.00°18'00"E., along the East line of Lot No. 3, a distance of 229.73 feet to the iron pipe, passing thru a concrete monument found at 32.80 feet, said iron pipe was the true PLACE OF BEGINNING.

Containing in all 0.132 acre of which 0.019 acre has been dedicated for highway purposes. The PLACE OF BEGINNING is at antiron pipe found at the Northwest Corner of Lot No. 2 of the Thuman's Subdivision as recorded in Plat Book "B", page 114 in the Auglaize County Recorder's Office;

thence S.00°16'22"W. along the East line of Lot No. 2, a distance of 229.72 feet to a point in the centerline of State Route 67, passing thru a concrete monument found at 196.92 feet in the Northerly Right-of-Way line of State Route 67;

thence S.66°30'00"W. along the centerline of State Route 67, a distance of 27.44 feet to a point;

thence N.00°17'11"E. a distance of 229:72 feet to an iron pin set, passing thru an iron pin set for reference at 32.80 feet:

thence N.66°28'00"E. along the North line of the Thuman Subdivision, a distance of 27.39 feet to the iron pipe found which was the true PLACE OF BEGINNING.
