



SURVEYOR'S DESCRIPTION FOR PARCEL NO. 1

The following described tract of land is part of the East half of the Southeast Quarter of Section 23, Town 6 South, Range 5 East, Washington Township, Auglaize County, Ohio and is more particularly described as follows:

The PLACE OF BEGINNING is at a R.R. spike found at the Southwest corner of the East Half of the Southeast Quarter of Section 23, Washington Township and in the intersection of the centerlines of State Route 219 and Township Road 117 (Knierim Road);

thence N.00°03'30"W. along the West line of the East Half of the Southeast Quarter of Section 23 and the centerline of Township Road 117, a distance of 1,212.31 feet to a R.R. spike found;

thence S.89°04'50"E., along an existing line as found in Survey Book "E", page 39, extended, a distance of 290.00 feet to an iron pin set, passing thru an iron pin found at 25.00 feet in the East Right-of-Way line of Township Road 117;

thence S.00°03'30"E. a distance of 300.46 feet to an iron pin set;

thence N.89°04'50"W. a distance of 98.26 feet to an iron pin set;

thence S.00°03'30"E. a distance of 905.84 feet to a point in the centerline of State Route 219, passing thru an iron pin set for reference at 875.84 feet in the North Right-of-Way line of State Route 219;

thence S.89°07'22"W. along the South line of the Southeast Quarter of Section 23 and the centerline of State Route 219, a distance of 191.73 feet to the R.R. spike which was the true PLACE OF BEGINNING.

Commencing at a R.R. spike found at the Southwest corner of the East Half of the Southeast Quarter of Section 23, Washington Township and in the intersection of the centerlines of State Route 219 and Township Road 117 (Knierim Road);

thence N.89°07'22"E. along the South line of the Southeast Quarter of Section 23 and the centerline of State Route 219, a distance of 191.73 feet to a point, which is the PLACE OF BEGINNING for the tract of land herein described;

thence N.00°03'30"W. a distance of 905.84 feet to an iron pin set, passing thru an iron pin set for reference at 30.00 feet in the North Right-of-Way line of State Route 219;

thence S.89°04'50"E. a distance of 98.26 feet to an iron pin set;

thence N.00°03'30"W. a distance of 300.46 feet to an iron pin set;

thence N.89°04'50"W. a distance of 138.60 feet to a point:

thence N.00°03'30"W. along an existing line as found in Survey Book "E", page 39, a distance of 450.00 feet to a point in the centerline of an open drainage ditch, passing thru an iron pin found for reference at the top of the bank at 431.75 feet;

thence \$.58°33'05"E, along the centerline of the open drainage ditch, a distance of 235.81 eet to a point;

thence S.70°42'24"E. along the centerline of the open drainage ditch, a distance of 182.31 feet to a point;

thence S.64°33'45"E. along the centerline of the open drainage ditch, a distance of 290.01 feet to a point, being referenced by an iron pin set at the top of the bank, S.00°06'39"W. a distance of 19.06 feet:

thence S.00°06'39"W. a distance of 1,340.07 feet to a point in the centerline of State Route 219, passing thru an iron pin set for reference at 1,310.07 feet in the North Right-of-Way line of State Route 219:

thence S.89°07'22"W. along the South line of the Southeast Quarter of Section 23 and the centerline of State Route 219, a distance of 590.59 feet to the point which was the true PLACE OF REGINNING.
