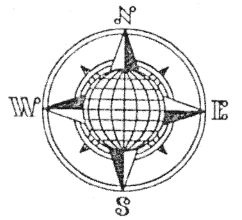


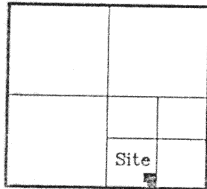

LOCATION PLAN

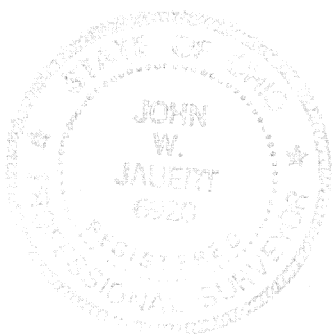
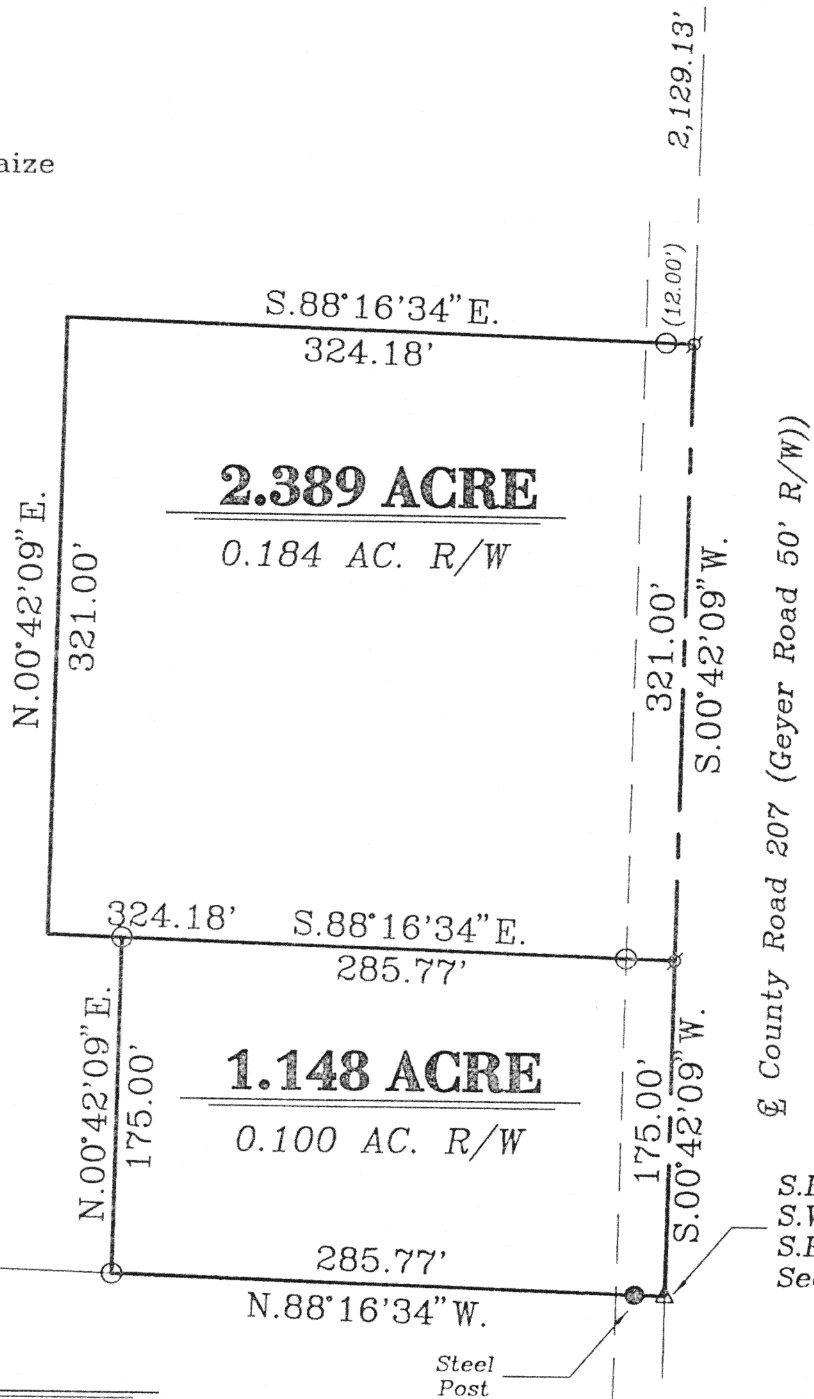

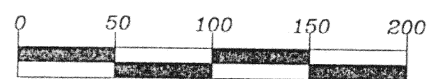


SURVEYORS DESCRIPTION FOR 1.148 ACRE PARCEL

thence N.88°16'34"W. a distance of 285.77 feet to an iron pin set, passing thru a steel corner post found at 10.50 feet;
thence N.00°42'09"E., parallel to the East line of the Southwest Quarter of the Southeast Quarter of Section 8, a distance of 175.00 feet to an iron pin set;
thence S.88°16'34"E. a distance of 285.77 feet to a P.K. Nail set, passing thru an iron pin set for reference at 260.77 feet in the West right-of-way line of County Road 207 (Geyer Road);
thence S.00°42'09"W. along the East line of the Southwest Quarter of the Southeast Quarter of Section 8, a distance of 175.00 feet to the R.R. Spike which was the true PLACE OF BEGINNING.

Containing in all 1.148 acre of which 0.100 Acre has been dedicated for highway purposes. thence N.88°16'34"W. a distance of 324.18 feet to a point, passing thru an iron pin set for reference at 25.00 feet in the West right-of-way line of County Road 207 (Geyer Road), also passing thru an iron pin set at 285.77 feet;

thence N.00°42'09"E., parallel to the East line of the Southwest Quarter of the Southeast Quarter of Section 8, a distance of 321.00 feet to a point;

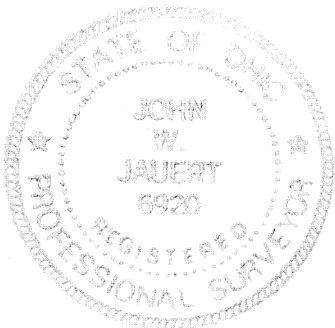
thence S.88°16'34"E. a distance of 324.18 feet to a P.K. Nail set, passing thru an iron pin set for reference at 312.18;
