
GREG SHOBE SURVEY

thence S.89°01'19"E., parallel to the centerline of County Road 150 and the South line of the Southeast Quarter of Section 25, a distance of 312.50 feet to an iron pin set;

thence S.00°50'41"W., parallel to the West line of the Southeast Quarter of Section 25, a distance of 320.00 feet to a P.K. Nail set in the centerline of County Road 150, passing thru an iron pin set for reference at 295.00 feet in the North right-of-way line of County Road 150;

thence N.89°01'19"W. along the centerline of County Road 150 and the South line of the Southeast Quarter of Section 25, a distance of 312.50 feet to the Monument Box which was the true PLACE OF BEGINNING.
