

## SURVEYORS DESCRIPTION FOR PARCEL NO. 1

Commencing at a Monument Box found at the Southwest corner of the Northwest Quarter of Section 33, Logan Township;

thence N.00°56'48"E. along the West line of the Southwest Quarter of Section 33 and the legal centerline of County Road 91 (Moulton-Ft. Amanda Road), a distance of 470.85 feet to a Mag Nail set, which is the PLACE OF BEGINNING for the tract of land herein described;

thence continuing N.00°56'48"E. along the above described line, a distance of 452.00 feet to a Mag Nail set;

thence S.88°59'49"E. a distance of 993.14 feet to an iron pin set, passing thru an iron pin set at 30.00 feet in the East right-of-way line of County Road 91;

thence S.00°59'18"W. a distance of 455.09 feet to an iron pin found;


thence N.88°49'07"W. a distance of 992.81 feet to the Mag Nail, passing thru an iron pin found at 962.81 feet in the East right-of-way line of County Road 91, said Mag Nail was the true PLACE OF BEGINNING.

Commencing at a Monument Box found at the Southwest corner of the Northwest Quarter of Section 33, Logan Township;

thence N.00°56'48"E. along the West line of the Southwest Quarter of Section 33 and the legal centerline of County Road 91 (Moulton-Ft. Amanda Road), a distance of 922.85 feet to a Mag Nail set, which is the PLACE OF BEGINNING for the tract of land herein described;

thence continuing N.00°56'48"E. along the above described line, a distance of 452.00 feet to a Mag Nail set over a R.R. Spike found;

thence S.88°59'49"E. a distance of 993.14 feet to an iron pin found, passing thru an iron pin found at 30.00 feet in the East right-of-way line of County Road 91;

thence S.00°59'18"W. a distance of 400.07 feet to an iron pin set;


