
## SURVEY FOR LARRY McLEAN

## SURVEYORS DESCRIPTION FOR 0.174 ACRE PARCEL

The following described tract of land is part of the Southwest Quarter of Section 18, Town 5 South, Range 6 East, Duchouquet Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a concrete corner post found at the Southwest corner of the Southwest Quarter of Section 18, Duchouquet Township;

thence N.01°41'00"E. along the West line of the Southwest Quarter of Section 18, a distance of 25.00 feet to an iron pin found;

thence S.88°42'07"E. a distance of 1,234.59 feet to a P.K. Nail found in the centerline of State Route 198;

thence N.21°07'00"W. along the centerline of State Route 198 a distance of 54.10 feet to a P.K. Nail found;

thence N.88°42'07"W. a distance of 262.69 feet to an iron pin found, which is the PLACE OF BEGINNING for the tract of land herein described;

thence continuing N.88°42'07"W. a distance of 20.00 feet to an iron pin set;

thence N.04°47'04"W. a distance of 232.71 feet to an iron pin set;

thence N.85°56'00"E. a distance of 45.00 feet to an iron pin found;

thence S.01°20'00"W. a distance of 235.61 feet to the iron pin which was the true PLACE OF BEGINNING.
