

LEGAL DESCRIPTION FOR 3.00 ACRE PARCEL SPLIT

The following described parcel of land is situated in the Southeast Quarter of Section 31, Moulton Township, Town-5-South, Range-5-East, Auglaize County, Ohio, and is more particularly described as follows:

Commencing for reference at a Monument box located at the Northeast Corner of the Southeast Quarter of Section 31, Moulton Township, Town-5-South, Range-5-East, Auglaize County, Ohio;

Thence with a bearing of S. 02°-05'-35" W. along the East line of the Southeast Quarter of said Section 31, and the centerline of Glynwood-New Knoxville Road (Township Road #81), for a distance of 450.07 feet to a P.K. Nail/Shiner (set) and the PLACE OF BEGINNING;

Thence continuing with a bearing of S. 02°-05'-35" W. along the East line of the Southeast Quarter of said Section 31, and the centerline of Glynwood-New Knoxville Road (Township Road #81), for a distance of 273.19 feet to a P.K. Nail (found);

Thence with a bearing of S. 84°-07'-05" W. along the Limited Access Right-of-Way line of Federal Route #33 for a distance of 442.57 feet to an iron pin (set), and also passing thru an iron pin (found) on the Right-of-Way line of Glynwood-New Knoxville Road at a distance of 131.27 feet;

Thence with a bearing of N. 02°-05'-35" E. for a distance of 323.12 feet to an iron pin (set);

Thence with a bearing of S. 89°-24'-24" E. for a distance of 438.44 feet to a P.K. Nail/Shiner (set), and passing thru an iron pin (set) on the Right-of-Way line of Glynwood-New Knoxville Road at a distance of 339.06 feet, said P.K. Nail/Shiner (set) being the original PLACE OF BEGINNING.

Containing in all 3.000 Acres of land, of which, 0.736 Acre being previously dedicated for highway purposes. The above described parcel of land is also subject to all other legal easements, reservations, or restrictions, if any, upon said premises.
