



DESCRIPTION FOR 9.557 ACRE TRACT

The following described tract of land is part of the Southeast Quarter of Section 35, Town 4 South, Range 6 East, Duchouquet Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at an iron rod found at the Northwest corner of the Southeast Quarter of Section 35, Duchouquet Township;

thence S.00°59'44"W. along the West line of the Southeast Quarter of Section 35, a distance of 730.16 feet to an iron pin set, which is the PLACE OF BEGINNING for the tract of land herein described:

thence N.89°53'41"E. along the South line of a 6.35 Acre tract of land as described in Deed Volume: 226, Page 526, a distance of 691.26 feet to a R.R. Spike found, passing thru an iron pin set at 646.26 feet in the West Right-of-Way line of County Road 25-A;

thence S.00°47'30"W. a distance of 606.00 feet to a Mine Spike found in the centerline of County Road 25-A;

thence N.89°20'25"W. along the North line of a 10.00 Acre tract of land as described in Deed Volume OR 122, Page 997, a distance of 693.30 feet to an iron pin found, passing thru an iron pin set at 45.00 feet in the West Right-of-Way line of County Road 25-A;

thence N.00°59'44"E. along the West line of the Southeast Quarter of Section 35, a distance of 596.78 feet to the iron pin which was the true PLACE OF BEGINNING.

Containing in all 9.557 Acre of which 0.625 Acre has been dedicated for highway purposes. The above described tract of land is subject to all legal easements, restrictions, and reservations, if any, of record or in use on said premises. Previous deed reference: Volume 155, page 101. This plat is recorded in Survey Book "K", page 512, in the Auglaize County Engineer's Office.
