





## SURVEYOR'S DESCRIPTION

The following described tract of land is part of the South one half of the Souhwest Quarter of Section 3, Town 6 South, Range 8 East, Goshen Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a Monument Box found at the Southwest corner of the Southwest Quarter of Section 3, Goshen Township and in the centerline of Township Road 130 (Goshen Road);

thence S.89°20'16"E. along the centerline of Township Road 130 and the South line of the Southwest Quarter of Section 3, a distance of 1,005.46 feet to a P.K. Nail (set) which is the PLACE OF BEGINNING for the tract of land herein described; thence N.00°39'44"E. a distance of 120.00 feet to an iron pin (set), passing thru an iron pin (set) for reference at 20.00 feet in the North Right-of-Way line of of Township Road 130;

thence S.89°20'16"E., parallel to the centerline of Township Road 130 and the South line of the Southwest Quarter of Section 3, a distance of 190.60 feet to an iron pin (set);

thence N.00°39'44"E. a distance of 75.00 feet to an iron pin (set); thence S.89°20'16"E. a distance of 140.00 feet to an iron pin (set); thence S.00°39'44"W. a distance of 195.00 feet to a P.K. Nail (set), passing

thence S.00°39'44"W. a distance of 195.00 feet to a P.K. Nail (set), passing thru an iron pin (set) for reference at 175.00 feet in the North Right-of-Way Line of Township Road 130;

thence N.89°20'16"W. a distance of 330.60 feet to the P.K. Nail (set), which was the true PLACE OF BEGINNING;

Containing in all 1.152 acres of which 0.152 acre has been dedicated for highway purposes.
