


thence S.00°45'41"W. along the centerline of Hardin County Line Road No. 15 and the Auglaize-Hardin County Line, a distance of 1,898.45 feet to a P.K. Nail (set);

thence S.67°59'41"W. a distance of 456.97 feet to an iron pin (set from a previous survey);

thence S.83°26'03"W. a distance of 1,215.78 feet to an iron pin (set from a previous survey);

thence S.83°27'05"W. a distance of 1,190.26 feet to a point in the centerline of the Kerr Open Ditch being the PLACE OF BEGINNING for the tract of land herein described;

thence S.04°23'28"E. a distance of 4,335.19 feet to a P.K. Nail (set), passing thru an iron pin (set) for reference at 4,305.06 feet in the North Right-of-Way line of State Route 385;

thence N.89°07'29"W. along the centerline of State Route 385, a distance of 288.66' to a P.K. Nail (set);
