

5.515 ACRE TOTAL 1.217 AC. R\W

The following described tract of land is part of the Northeast Quarter of Section 6, Town 6 South, Range 6 East, Pusheta Township and part of the Southeast Quarter of Section 31, Town 5 South, Range 6 East, Duchouquet Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at an O.D.O.T. Monument (found at Sta. 38+95.42) at the Northeast corner of the Northeast Quarter of Section 6, Pusheta Township and in the former centerline of County Road 140 (Canning Factory Road);

thence S.00'54'51"W. along the East line of the Northeast Quarter of Section 6, a distance of 87.46 feet to an iron pin (set), which is the PLACE OF

BEGINNING for the tract of land herein described; thence continuing S.00°54'51"W. along the above described line, a distance of 133.75 feet to a P.K. Nail (set) in the centerline of relocated County Road 140; thence along a non-tangent curve to the left having the following curve data: $\triangle = 56^\circ00^\circ02^*$ Rt., R = 954.93 feet, an arc distance of 405.34 feet, the chord of which bears N.61'46'06"W. a distance of 402.30 feet to a P.K. Nail (set);

thence N.12'28'58"E. a distance of 36.97 feet to an iron pin (set); thence N.89'08'47"W. along the North line of the Northeast Quarter of Section 6 and the former centerline of County Road 140, a disatance of 298.62

thence N.01'51'44"E. a distance of 544.16 feet to an iron pin (set), passing that an iron pin (set) for reference at 33.06 feet in the North right-of-way line of

County Road 140;
thence S.6702'27"E. along the limited access right-of-way line of U.S.
Route 33, a distance of 135.84 feet to an iron pin (set);
thence S.57'06'55"E. along the limited access right-of-way line of U.S.
Route 33, a distance of 203.04 feet to an iron pin (set);
thence S.41'37'55"E. along the limited access right-of-way line of U.S.
Route 33, a distance of 221.42 feet to a 3 inch dia. steel right-of-way fence post;
thence S.25'08'05"E. along the limited access right-of-way line of U.S.
33, a distance of 285.16 feet to an iron pin (set), possing thru an iron pin (set)
at 227.44 feet in the former North right-of-way line of old County Road 140 and
passing thru an iron pin (set) at 256.30 feet in the centerline of former C.R. 140;
thence S.37'12'07"E. along the limited access right-of-way line of U.S. Route
33. a distance of 79.33 feet to the iron pin which was the true PLACE OF BEGINNING
