







Commencing at a R.R. Spike (O.D.O.T. Sta 256+08.00 (found) in the intersection of the centerlines of State Route 198 and Township Road 180 (Wapak-Buckland Road);  
thence S.24°32'23"E. along the centerline of State Route 198 a distance of 879.01 feet to a P.K. Nail (found), which is the PLACE OF BEGINNING for the tract of land herein described;

thence N.65°05'48"E. a distance of 151.81 feet to an iron pipe (found), passing thru an iron pipe for reference (found) at 29.76 feet;

thence S.88°50'56"E. a distance of 175.47 feet to an iron pin (set);

thence S.01°24'17"W. a distance of 156.80 feet to an iron pin (set);

thence N.88°35'43"W. a distance of 84.38 feet to an iron pin (set);

thence S.65°05'48"W. a distance of 165.45 feet to a P.K. Nail (set), passing thru an iron pin (set) for reference at 135.45 feet in the Easterly right-of-way line of State Route 198;

thence N.24°32'23"W. along the centerline of State Route 198, a distance of 180.24 feet to the P.K. Nail which was the true PLACE OF BEGINNING.

Containing in all 1.124 Acre of which 0.124 Acre has been dedicated for highway purposes. Commencing at a R.R. Spike (O.D.O.T. Sta 256+08.00 (found) in the intersection of the centerlines of State Route 198 and Township Road 180 (Wapak-Buckland Road);  
thence S.24°32'23"E. along the centerline of State Route 198 a distance of 1,059.25 feet to a P.K. Nail (set), which is the PLACE OF BEGINNING for the tract of land herein described;

thence N.65°05'48"E. a distance of 165.45 feet to an iron pin (set), passing thru an iron pin (set) for reference at 30.00 feet in the Easterly right-of-way line of State Route 198;

thence S.88°35'43"E. a distance of 84.38 feet to an iron pin (set);

thence N.01°24'17"E. a distance of 156.80 feet to an iron pin (set);

thence S.88°50'56"E. a distance of 509.33 feet to a 6 inch dia. wooden corner post (found) in the Moulton - Duchouquet Township Line;

thence S.01°04'44"W. along the Township line and the East line of the Northeast Quarter of Section 13, Moulton Township, a distance of 219.10 feet to an iron pin (found);

thence N.88°35'43"W., parallel to the North line of the Northeast Quarter of Section 13, a distance of 580.92 feet to an iron pin (found);

thence S.65°05'48"W. a distance of 151.81 feet to a P.K. Nail (found), passing thru an iron pin (found) in the Easterly right-of-way line of State Route 198;

thence N.24°32'23"W. along the centerline of State Route 198, a distance of 60.00 feet to the P.K. Nail which was the true PLACE OF BEGINNING.
