

Located in the North Half of the Northwest Fractional Quarter of Section 6, Duchouquet Township, T-5-S, R-6-E, Auglaize County, Ohio



## DESCRIPTION FOR 3.164 ACRE PARCEL

The following described parcel of land is situated in the North Half of the Northwest Fractional Quarter of Section 6, Duchouquet Township, Town-5-South, Range-6-East, County of Auglaize, State of Ohio, and is more particularly described as follows:

Commencing for reference at a Monument Box located at the Northwest Corner of the Northwest Fractional Quarter of said Section 6, Duchouquet Township;

Thence with a bearing of S.  $00^{\circ}-40'-24''$  E. along the West line of the Northwest Fractional Quarter of said Section 6, and the centerline of Short Line Road (T.R. #131), for a distance of 1,040.12 feet to a P.K. Nail/Shiner (set) and the PLACE OF BEGINNING;

Thence with a bearing of N.  $88^{\circ}-20'-59"$  E. for a distance of 477.00 feet to an iron pin (set);

Thence with a bearing of S.  $00^{\circ}-40'-24''$  E. for a distance of 289.00 feet to a P.K. Nail/Shiner (set) on the centerline of Ritchie Road (T.R. #198), and passing thru an iron pin (set) for reference at 269.00 feet;

Thence with a bearing of S.  $88^{\circ}-20'-59"$  W. along the South line of the North Half of the Northwest Fractional Quarter of said Section 6, and the centerline of Ritchie Road (T.R. #198), for a distance of 477.00 feet to a Railroad Spike (found) at the Southwest Corner of the North Half of the Northwest Fractional Quarter of said Section 6;

Thence with a bearing of N.  $00^{\circ}-40'-24"$  W. along the West line of the Northwest Fractional Quarter of said Section 6, and the centerline of Short Line Road (T.R. #131), for a distance of 289.00 feet to a P.K. Nail/Shiner (set) and the PLACE OF BEGINNING;

Containing in all 3.164 Acres, of which, 0.343 Acre being previously dedicated for highway purposes. The above described parcel of land is also subject to all other legal easements, reservations, or restrictions, if any, upon said premises. Previous Deed References: Deed Volume OR13, Page 180.
