
LOCATION PLAN



SURVEYORS DESCRIPTION FOR 2.109 ACRE TRACT

The following described tract of land is part of the Northeast Quarter of Section 33, Town 6 South, Range 4 East, St. Marys Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a monument box at the Northeast corner of the Northeast Quarter of Section 33, St. Marys Township and in the centerline of Township Road 90 (Southland Road); thence N.89°15'40"W. along the centerline of Township Road 90 and the North line of the Northeast Quarter of Section 33, a distance of 450.12 feet to a P.K. Nail (found) in the centerline of County Road 66-A;

thence S.06°22'37"W. along the centerline of County Road 66-A, a distance of 1,345.60 feet to a P.K. Nail (set), which is the PLACE OF BEGINNING for the tract of land herein described;

thence S.83°37'23"E. a distance of 525.00 feet to an iron pin (set), passing thru an iron pin (set) for reference at 55.00 feet in the East right-of-way line of County Road 66-A;

thence S.06°22'37"W. a distance of 175.00 feet to an iron pin (set);

thence N.83°37'23"W. a distance of 524.98 feet to a P.K. Nail (set), passing thru an iron pin (set) for reference at 469.98 feet in the East right-of-way line of County Road 66-A;

thence along the curved centerline of County Road 66-A, along a curve to the right, an arc distance of 5.35 feet, the chord of which bears N.06°13'00"E., a distance of 5.35 feet and a radius of 954.93 feet to a P.K. Nail (set);

thence N.06°22'37"E. along the centerline of County Road 66-A, a distance of 169.65 feet to the P.K. Nail, which was the true PLACE OF BEGINNING.

SURVEYORS DESCRIPTION FOR 2.130 ACRE TRACT

Commencing at a monument box at the Northeast corner of the Northeast Quarter of Section 33, St. Marys Township and in the centerline of Township Road 90 (Southland Road);

thence N.89°15'40"W. along the centerline of Township Road 90 and the North line of the Northeast Quarter of Section 33, a distance of 450.12 feet to a P.K. Nail (found) in the centerline of County Road 66-A;

thence S.06°22'37"W. along the centerline of County Road 66-A, a distance of 1,515.25 feet to a P.K. Nail (set);

thence along the curved centerline of County Road 66-A, along a curve to the left, an arc distance of 5.35 feet, the chord of which bears \$.06°13'00"W, a distance of 5.25 feet to a P.K. Nail (set), which is the PLACE OF BEGINNING for the tract of land herein described;

thence S.83°37'23"E. a distance of 524.98 feet to an iron pin (set), passing thru an iron pin (set) for reference at 55.00 feet in the East right-of-way line of County Road 66-A;

thence S.06°22'37"W. a distance of 175.00 feet to an iron pin (set);

thence N.84°29'24"W. a distance of 506.37 feet to a P.K. Nail (found), passing thru an iron pin (found) for reference at 450.38 feet in the East right-of-way line of County Road 66-A;


