SURVEYOR'S DESCRIPTION FOR 3.384 ACRES

The following described parcel of land is located in the East Half of the Northeast Quarter of Section 36, St. Mary's Township, Town-6-South, Range-4-East, Auglaize County, Ohio, and is more particularly described as follows:

Commencing for reference at a Monument Box located at the Northwest Corner of the Northeast Quarter of said Section 36, St. Mary's Township;

Thence with a bearing of S. $89^{\circ}-15'-55"$ E. along the North line of the Northeast Quarter of said Section 36, St. Mary's Township, and the centerline of Southland Road, T.R. #90, for a distance of 1,335.44 feet to a P.K. Nail (found) and the PLACE OF BEGINNING;

Thence continuing with a bearing of S. $89^{\circ}-15'-55''$ E. along the North line of the Northeast Quarter of said Section 36, St. Mary's Township, and the centerline of Southland Road, T.R. #90, for a distance of 352.87 feet to a P.K. Nail/Shiner (set);

Thence with a bearing of S. $01^{\circ}-04'-15"$ W. for a distance of 367.21 feet to an iron pin (set), and passing thru and iron pin (set) for reference at 20.00 feet;

Thence with a bearing of S. 74° -45'-40" W. for a distance of 367.66 feet to an iron pin (set);

Thence with a bearing of N. $01^{\circ}-04'-15"$ E. for a distance of 468.39 feet to a P.K. Nail (found) and passing thru an iron pin (set) for reference at 448.39 feet, said P.K. Nail found being the original PLACE OF BEGINNING.

The above described parcel of land shall reserve a 16 foot wide strip of ground for ingress-egress to be used for agricultural purposes only, the centerline of said 16 foot wide easement being described as follows:

Commencing at the Northwest Corner of the above described 3.384 Acres of land;

Thence with a bearing of S. $32^{\circ}-53'-35''$ E. for a distance of 471.76 feet to a point on the Southerly line of the above described 3.384 Acre parcel and there to terminate.
