

Part of the Northeast Quarter of Section 33, T-6-S, R-4-E, St. Marys Township, Auglaize County, Ohio.




N.E. Corner, N.E. Quarter,-Section 33.

thence S.00°59'01"W., along the centerline of a creek, a distance of 212.10 feet to an iron pin set;

thence N.89°15'40"W., parallel to the North line of the Northeast Quarter of Section 33 and the centerline of Township Road 90, a distance of 98.64 feet to an iron pin found;

thence N.06°22'37"E. a distance of 213.13 feet to a P.K. Nail found;




