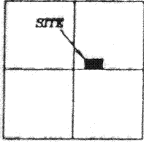


LOCATION PLAN

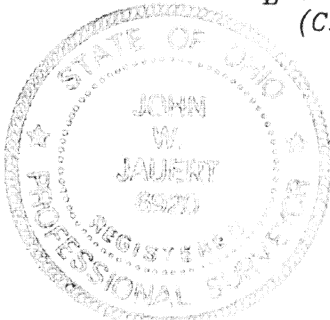
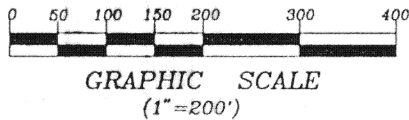
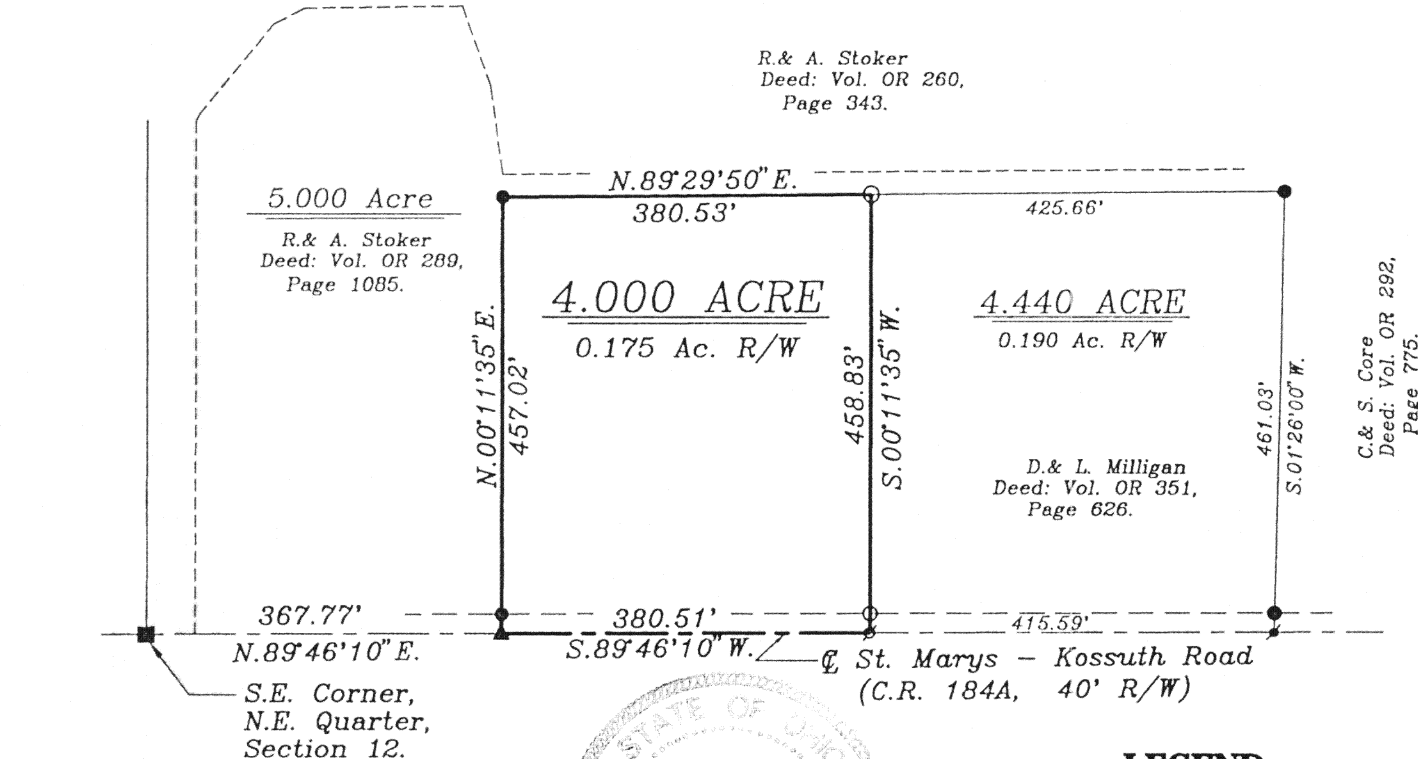
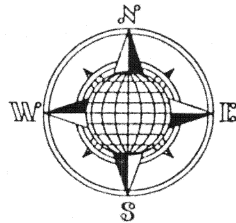

SURVEYOR'S DESCRIPTION

The following described tract of land is part of the Southwest Quarter of the Northeast Quarter of Section 12, Town 5 South, Range 4 East, Noble Township, Auglaize County, Ohio and is more particularly described as follows:

Commencing at a Monument Box at the Southwest corner of the Northeast Quarter of Section 12, Noble Township and in the centerline of County Road 184A, (St. Marys - Kossuth Road);

thence N.89°46'10"E. along the centerline of County Road 184A and the South line of the Northeast Quarter of Section 12, a distance of 367.77 feet to a Gin Spindle found, which is the PLACE OF BEGINNING for the tract of land herein described;

thence N.00°11'35"E. a distance of 457.02 feet to an iron pin found;

thence N.89°29'50"E. a distance of 380.53 feet to an iron pin set;

thence S.00°11'35"W. a distance of 458.83' feet to a P.K. Nail set, passing thru an iron pin set for reference at 438.83 feet in the Northerly Right-of-Way line of County Road 184A;

thence S.89°46'10"W. along the centerline of County Road 184A and the South line of the Northeast Quarter of Section 12, a distance of 380.51 feet to the Gin Spindle, which was the true PLACE OF BEGINNING.

Containing in all 4.000 acres of which 0.755 acre has been dedicated for highway purposes. The above described tract of land is subject to all legal easements, restrictions and reservations, if any, of record or in use on said premises. Previous deed reference: Vol.OR 351, Page 626. This plat and description is recorded in Survey Book "K", page 788, in the Auglaize County Engineer's Office. Basis of bearings is per an adjacent 5.000 Acre survey by James Kent.
