



LEGAL DESCRIPTION

scale:

Being a twenty (20) foot wide easement for pipeline purposes, located in the west half of the northwest quarter of Section 8, T-6-S, R-6-E, Pusheta Township, Auglaize County, Ohio and more particularly described as follows:

Commencing at a railroad spike found at the intersection of the north line of said west half of said northwest quarter with the centerline of Hardin Pike Road (CR 133-A); thence, S 12 degrees 08' 00" W with the centerline of said Hardin Pike Road for a distance of 629.86 feet to a p-k nail (found); thence, S 41 degrees 15' 46" E, along the centerline of a creek, for a distance of 156.08 feet to a point; thence, continuing along said centerline of said creek S 16 degrees 00' 57" W, for a distance of 175.24 feet; thence, S 28 degrees 17' 05" E for a distance of 165.39 feet to a point; thence, S 73 degrees 50' 00' E, for a distance of 193.06 feet to the centerline of the aforesaid creek; thence S 12 degrees 08' 00" W, (passing through a 5/8" re-rod w/cap (found) as a reference for the bearing of the easterly line of a certain parcel surveyed by Richard Morrisey, PS 6470, dated 1/15/88 and filed in survey book H-688, at a distance of 43.73 feet) for a total distance of 52.73 feet to the **PLACE OF BEGINNING**, for the easement described herein;

thence, S 30 degrees 05' 42" E, for a distance of 967.75 feet to a point;

thence, S 44 degrees 57' 39" E, for a distance of 100.98 feet to a point on the westerly line of a certain parcel surveyed by Thomas Kuck, PS 4996, dated 6/9/76;

thence, S 11 degrees 33' 20" W, along the westerly line of the aforesaid parcel, for a distance of 23.98 feet to a point;

thence, N 44 degrees 57' 39" W, for a distance of 116.82 feet to a point;

thence, N 30 degrees, 05' 42" W, for a distance of 948.33 feet to the easterly line of the aforesaid parcel as surveyed by Mr. Morrisey;

thence, N 12 degrees 08' 00" E, along said easterly line, for a distance of 29.76 feet to the **PLACE OF BEGINNING**, containing therein 21,338 square feet or 0.489 acres.
