

LEGAL DESCRIPTION

scale:

Being a part of the southwest quarter of Section 12, T-6-S, R-6-E, Pusheta Township, Auglaize County, Ohio and more particularly described as follows:

Commencing at a monument box (found) at the southwest corner of said Section 12 and the legal centerline intersection of Pusheta Road and Brown Road; thence, N 00 degrees 30' E along the centerline of said Brown Road, for a distance of 1440.12 feet to a railroad spike (found), said spike being the **POINT OF BEGINNING** for the tract herein described;

thence, continuing N-00 degrees 32' E along the aforesaid centerline of Brown Road, for a distance of 50.01 feet to a cotton gin spindle (set);

thence, N 89 degrees 11' E (passing through a cotton gin spindle set in the stump of a tree at a distance of 20.00 feet) for a total distance of 295.16 feet to a 5/8" re-rod w/cap (set);

thence, S 00 degrees 30' W for a distance of 50.01 feet to a 5/8" re-rod (found);

thence, S 89 degrees 11' W parallel with and fifty (50) feet from the second to the last course recited herein, (passing through a 1.5" iron pipe (found) at a distance of 275.16 feet) for a total distance of 295.16 feet to the **POINT OF BEGINNING**, containing therein 14,760 square feet.
