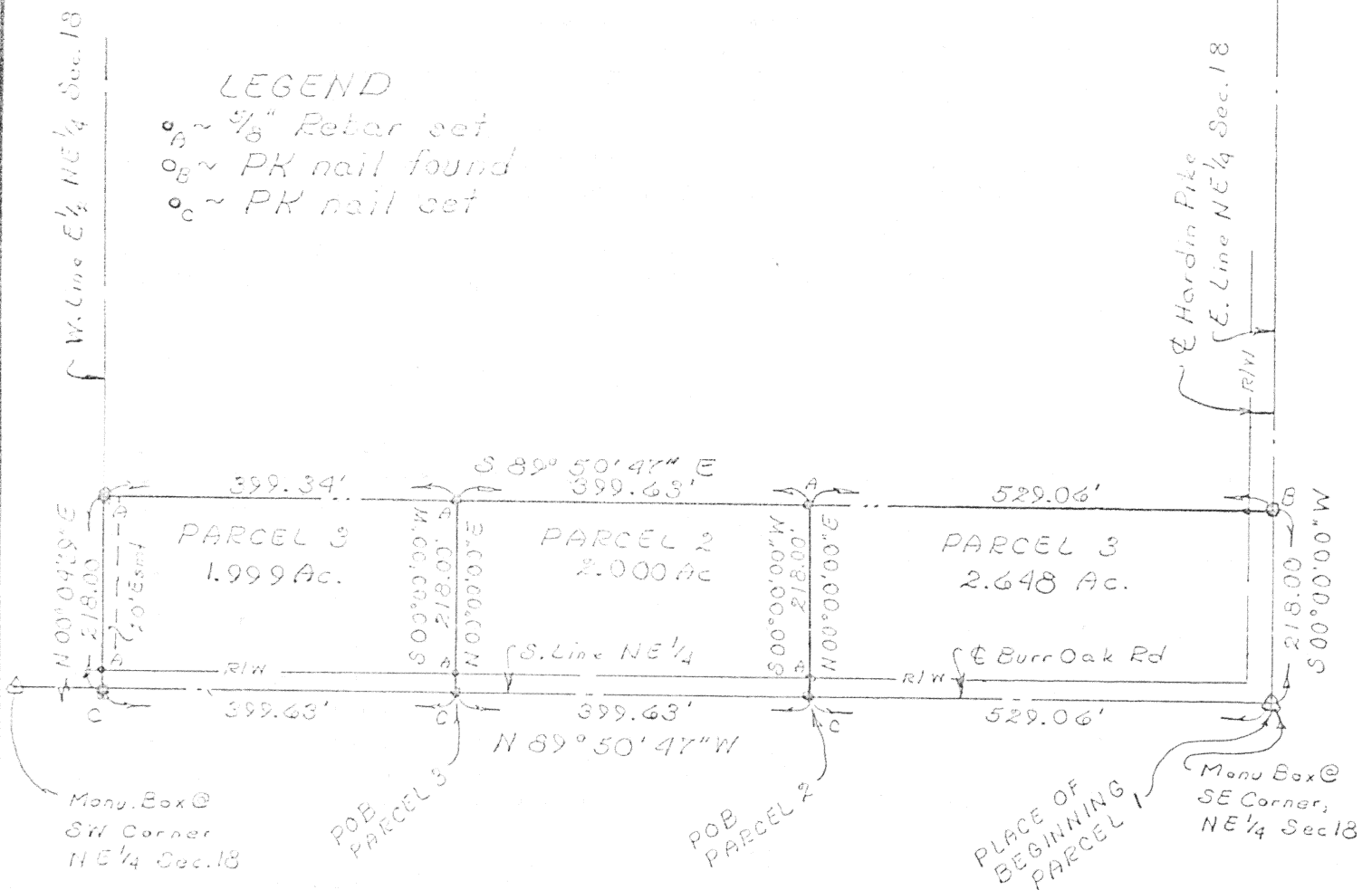

BEGINNING at a monument box found at the southeast corner of said Northeast quarter of said Section 18; thence N 89°50'47" W with the south line of said Northeast quarter of said Section 18 (also the centerline of Burr Oak Road), 529.06 feet to a PK nail set; thence N 00°00'00" E (passing through a 5/8 inch rebar set at 20.00 feet), 218.00 feet to a 5/8 inch rebar set; thence S 89°50'47" E, 529.06 feet to a PK nail found on the east line of said Northeast quarter; thence S 00°00'00" W with said east line (also the centerline of Hardin Pike), 218.00 feet to the PLACE OF BEGINNING containing 2.648 acres more or less and subject to all highways and other legal easements of record.

Commencing at a monument box found at the southeast corner of said Northeast quarter of said Section 18; thence N 89°50'47" W with the south line of said Northeast quarter of said Section 18 (also the centerline of Burr Oak Road), 928.69 feet to a PK nail set and the PLACE OF BEGINNING; thence continuing N 89°50'47" W with said south line and centerline, 399.63 feet to a PK nail set at the southwest corner of the east half of said Northeast quarter; thence N 00°04'39" E with the west line of said east half of said Northeast quarter (passing through a 5/8 inch rebar set at 20.00 feet), 218.00 feet to a 5/8 inch rebar set; thence S 89°50'47" E, 399.34 feet to a 5/8 inch rebar set; thence S 00°00'00" W (passing through a 5/8 inch rebar set at 188.00 feet), 218.00 feet to the PLACE OF BEGINNING containing 1.999 acres more or less and subject to all highways and other legal easements of record, including but not limited to a twenty (20) foot wide ingress and egress easement along the entire west side of this parcel.
