Commencing at the calculated position of the southwest corner of Section 19, said point also being the centerline of State Route 219; thence, N 01 degree 08' 52" E along the west line of the southwest quarter of Section 19, for a distance of 2151.04 feet to a railroad date nail {#41} found on a wood fence post, said date nail being the POINT OF BEGINNING for the tract herein described;

thence, continuing N 01 degree 08' 52" E along the aforesaid west line of the southwest quarter of said Section 19, for a distance of 496.65 feet to the calculated position of the obliterated East quarter corner of Section 24, Washington Township;

thence, N 01 degree 04' 02" E (passing through a cotton gin spindle set at the West quarter corner of Section 19 at a distance of 8.58 feet) and along the west line of the northwest quarter of Section 19 for a total distance of 644.86 feet to a cotton gin spindle (set) on the centerline of pavement of Headapohl Road;


