




scale:

Being a part of the northeast quarter of Section 6, T-5-S, R-5-E, Logan Township, Auglaize County, Ohio and more particularly described as follows:

Commencing at a monument box (found) at the southwest corner of the southeast quarter of the northeast quarter of said Section 6, and the legal centerline of Williams Road;


thence, with an assumed bearing of N 00 degrees 00' 00" E, along the centerline of Williams Road and the West line of the southeast quarter of the northeast quarter of said Section 6 for a distance of 258.72 feet to a cotton gin spindle (set), said point being the **POINT OF BEGINNING** for the Tract herein described;


thence, continuing N 00 degrees 00' 00" E along the aforesaid centerline and West line, for a distance of 258.72 feet to a cotton gin spindle (found);

thence, N 89 degrees 58' 43" E (passing through a 5/8" re-rod w/cap found on the easterly right-of-way line of Williams Road at a distance of 25.00 feet) for a total distance of 660.98 feet to a 5/8" re-rod w/cap (found);

thence, S 00 degrees 02' 17" W for a distance of 258.87 feet to a 5/8" re-rod w/cap (set);





Beginning at a monument box (found) at the southwest corner of the southeast quarter of the northeast quarter of said Section 6, and the legal centerline of Williams Road;



thence, S 00 degrees 02' 17" W for a distance of 258.87 feet to a 5/8" re-rod w/cap (found);

thence, N 89 degrees 59' 46" W (passing through a 5/8" re-rod w/cap found on the easterly right-of-way line of Williams Road at a distance of 635.63 feet), for a total distance of 660.63 feet to the **Point of Beginning**, containing therein 3.925 acres, of which 0.148 acres is road right-of-way.
