



LEGAL DESCRIPTION

scale:

Being a part of the southeast quarter of the northeast quarter of Section 19, Town 4 South, Range 5 East, Logan Township, Auglaize County, Ohio and more particularly described as follows:

Commencing at a monument box (found) at the southeast corner of the of the southeast quarter of the northeast quarter of Section 19, said box also being the legal centerline of Eisley Road; thence, with a GPS bearing of N 01 degree 03' 35" E along the east line of the southeast quarter of the northeast quarter and the legal centerline of Eisley Road, for a distance of 1085.24 feet to a cotton gin spindle (set), said spindle being the **POINT OF BEGINNING** for the parcel herein described;

thence, N 88 degrees 53' 05" W (passing through a 5/8" re-rod w/cap set on the westerly right-of-way line of Eisley Road at a distance of 30.00 feet) for a total distance of 238.71 feet to a 5/8" re-rod w/cap (set);

thence, N 01 degree 03' 35" E (passing through a 5/8" re-rod w/cap set on the southerly right-of-way line of Deep Cut road at a distance of 208.71 feet) for a total distance of 238.71 feet to a cotton gin spindle (set) on the north line of the southeast quarter of the northeast quarter of Section 19 and the legal centerline of Deep Cut Road;

thence, S 88 degrees 53' 05" E along the aforesaid north line and legal centerline, for a distance of 238.71 feet to a monument box (found) at the northeast corner of the southeast quarter of the northeast quarter of Section 19 and the legal centerline intersection of Deep Cut Road and Eisley Road;

thence, S 01 degree 03' 55" W along the east line of the southeast quarter of the northeast quarter of Section 19 and the legal centerline of Eisley Road, for a distance of 238.71 feet to the **POINT OF BEGINNING**, containing therein 1.308 acres, of which 0.308 acres is road right-of-way. Subject to all easements and right-of-way of record at the time of the recording of this instrument. Prepared by James M.
