


Beginning at the monument box found at the northeast corner of said quarter in the centerline of Esley Road; thence South (S 0° 00' 00" E), along the centerline of said Road, assumed bearing, and the east line of said quarter, one hundred sixty-five and zero hundredths (165.00) feet to a PK nail set; thence North eighty-nine degrees fifty-three minutes fifty-eight seconds West (N 89° 53' 58" W) thirty and zero hundredths (30.00) feet to a 1/2 inch re-rod set; thence North eighty-nine degrees fifty-three minutes fifty-eight seconds West (N 89° 53' 58" W) three hundred forty-seven and zero hundredths (347.00) feet to a 1/2 inch rerod set; thence North (N 0° 00' 00" E) one hundred sixty-five and zero hundredths (165.00) feet to a 1/2 inch re-rod set in the north line of said quarter,; thence South eighty-nine degrees fifty-three minutes fifty-eight seconds East (S 89° 53' 58" E), in the north line of said quarter, three hundred fortyseven and zero hundredths (347.00) feet to a 1/2 inch re-rod set; thence South eighty-nine degrees fifty-three minutes fifty-eight seconds East (S 89° 53' 58" E), in the north line of said quarter, thirty and zero hundredths (30.00) feet to the place of beginning containing one and four hundred twenty-eight thousandths (1.428) acres, more or less, subject to legal highways and all easements and restrictions of record.

All 1/2" re-rods set, as called for above, are thirty (30) inches long, are set flush or below the surface, and are topped with a plastic Permamark® cap stamped "LS 5772". This description and accompanying plat represents a boundary survey completed under my supervision on November 11, 1996 and all markers called for above are in place.
