



LEGAL DESCRIPTION

Being a part of the southeast quarter of the northwest quarter of Section 8, T-5-S, R-7-E, Union Township, Auglaize County, Ohio as evidenced by Deed Volume 185, Page 317 and more particularly described as follows:

Commencing at a monument box (found) marking the location of the southeast corner of the northwest quarter (Center of Section) of Section 8 and the legal centerline of Miller Road; thence, S 89 degrees 48' 12" W along the south line of the southeast quarter of the northwest quarter of Section 8, and the legal centerline of said Miller Road, for a distance of 375.53 feet to a cotton gin spindle (set), said spindle being the POINT OF BEGINNING for the tract herein described:

thence, continuing S 89 degrees 48' 12" W along the aforesaid south line and legal centerline of Miller Road, for a distance of 918.76 feet to a cotton gin spindle (set) on the easterly right-of-way line of the Ohio & Indiana Railroad;

thence, N 00 degrees 51' 48" E (passing through a 5/8" re-rod w/cap set on the northerly right-of-way line of Miller Road at a distance of 22.50 feet) and along the aforesaid easterly right-of-way line of the Ohio & Indiana Railroad, for a total distance of 1330.64 feet to a 5/8" re-rod w/cap (set) on the north line of the southeast quarter of the northwest quarter of Section 8;

thence, N 89 degrees 47' 37" E along the aforesaid north line, for a distance of 914.68 feet to a 5/8" re-rod w/cap (set);

thence, S 00 degrees 41' 15" W and parallel with the east line of the southeast quarter of the northwest quarter of said Section 8 (passing through a 5/8" re-rod w/cap set on the northerly right-of-way line of Miller Road at a distance of 1308.23 feet) for a total distance of 1330.73 feet to the POINT OF BEGINNING, containing therein 28.000 acres, of which 0.474 acres is road right-of-way. Subject to all easements and right-of-way per record at the time of the recording of this instrument. Prepared by James M.
