
PLAT OF A SURVEY IN THE N.E. 1/4 OF SECTION 13, T-5-S, R-7-E, UNION TOWNSHIP AUGLAIZE COUNTY, OHIO

SURVEY MADE ON ANTHONY FARM





Being a parcel of land situated in the northeast 1/4 of section 13, Township 5 south, Range 7 east, Union Township, Auglaize County, Ohio, and being part of the R. Anthony lands described in O.R. vol. 100, pg. 573, more particularly described as follows: Beginning at a railroad spike set on the east line of section 13 and in Township Rd. 251 (Santa Fe Line Rd.), this point being 1315.63 feet, S. 000-0'-0" W., of a monument box found for the northeast corner of section 13;

(1) Thence S. $00^{\circ}-0'-0''$ W., along the east line of section 13 and in Township Rd. 251

(Santa Fe Line Rd.), for 50.00 feet to a railroad spike found—
(2) Thence S. 90°-0'-0" W., for 882.00 feet to a 1/2" iron pin set, passing at 20.00 feet and at 362.00 feet 5/8" iron pins found-

(3) Thence N. 00°-0'-0" E. for 419.00 feet to a 1/2" iron pin set-

(4) Thence N. 90°-0'-0" E. for 520.00 feet to a 1/2" iron pin set-(5) Thence S. 00°-0'-0" W. for 369.00 feet to a 1/2" iron pin set-(6) Thence N. 90°-0'-0" E. for 362.00 feet to the point of beginning, 342.00 feet a 1/2" iron pin set.

Containing in all 5.418 acres of land, subject however to all legal easements rights of way.
