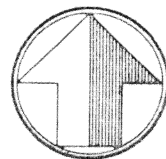
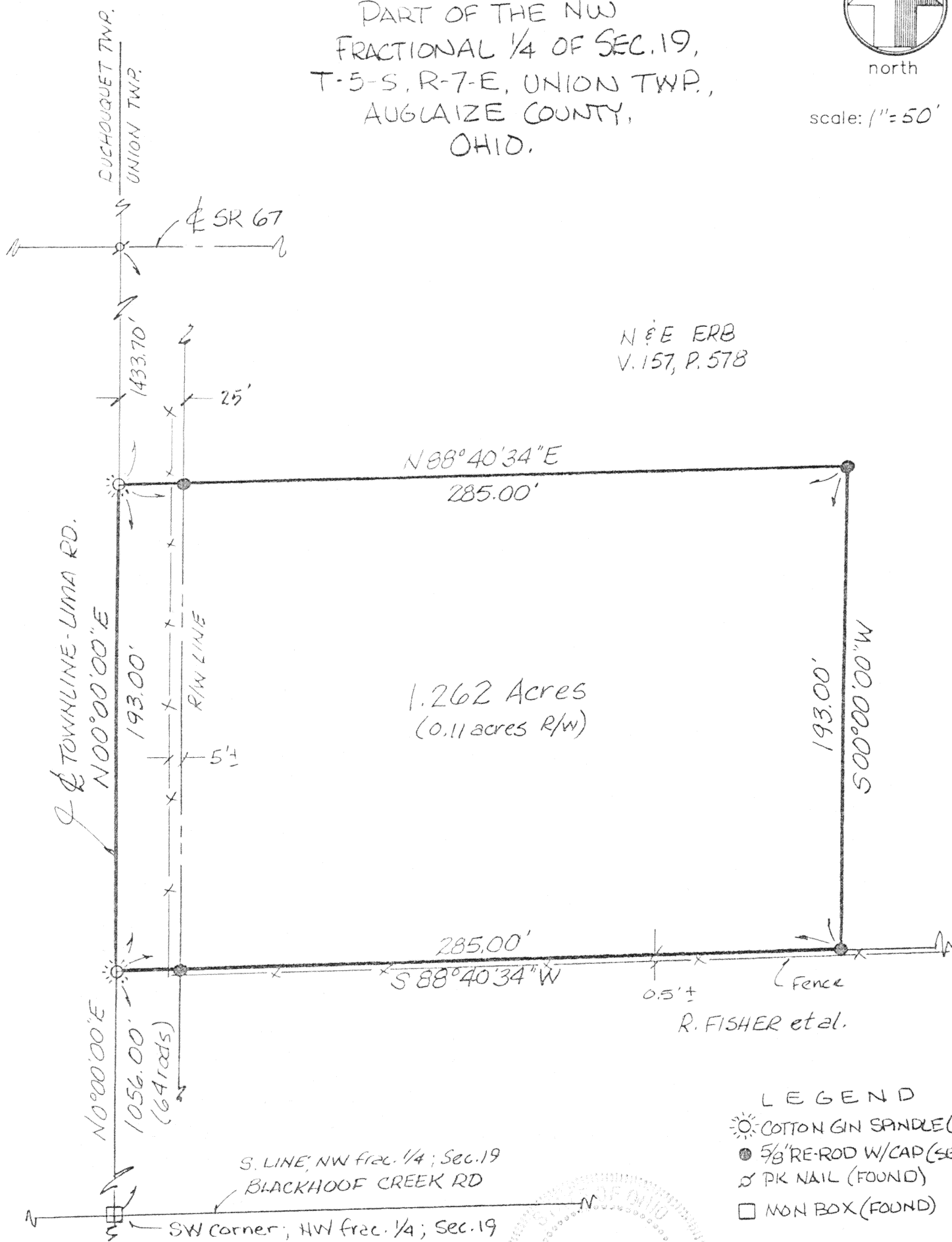


PART OF THE NW

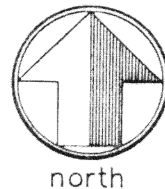

### LEGAL DESCRIPTION

Being a part of the northwest fractional quarter of Section 19, T-5-S, R-7-E, Union Township, Auglaize County as evidenced by Deed Volume 157, Page 578 and more particularly described as follows:

Commencing at a monument box marking the location of the southwest corner of the northwest fractional quarter of said Section 19 and the centerline intersection of Blackhoof Creek Road with Townline-Lima Road; thence, with an assumed bearing of N 00 degrees 00' 00" E along the West line of the northwest fractional quarter of said Section 19 and the centerline of Townline-Lima Road, for a distance of 1056.00 feet to a cotton gin spindle (set), said spindle being the **POINT OF BEGINNING** for the parcel herein described;


thence, continuing along the West line of the northwest fractional quarter of said Section 19 and the centerline of Townline Lima Road, for a distance of 193.00 feet to a cotton gin spindle (set);

thence, N 88 degrees 40' 34" E (passing through a 5/8" re-rod w/cap set on the easterly right-of-way line of said Townline-Lima Road at a distance of 25.00 feet) for a total distance of 285.00 feet to a 5/8" re-rod w/cap (set);

thence, S 00 degrees 00' 00" W for a distance of 193.00 feet to a 5/8" re-rod w/cap (set) on the southerly line of that tract evidence by Deed Volume 157, Page 578;

thence, S 88 degrees 40' 34" W along the South line of the aforesaid tract (passing through a 5/8" re-rod w/cap set on the easterly right-of-way line of Townline-Lima Road at a distance of 260.00 feet) for a total distance of 285.00 feet to the **POINT OF BEGINNING**, containing therein 1.262 acres, of which 0.11 acres is road right-of-way.
