Commencing at the monument box found at the northwest corner of said quarter in the centerline of Rinehart Road; thence South (S 0° 00' 00" E), in the centerline of said road, assumed bearing, and the west line of said quarter, one thousand three hundred twenty-three and twenty-seven hundredths (1,323.27) feet to a railroad spike found at THE PLACE OF BEGINNING; thence South (S 0° 00' 00" E) two hundred ninety-one and zero hundredths (291.00) feet to a Magnail set; thence South eighty-nine degrees three minutes eight seconds East (S 89° 03' 08" E), through a 5/8 inch rerod set at thirty and zero hundredths (30.00) feet, seven hundred twenty-nine and twenty-five hundredths (729.25) feet to a 5/8 inch re-rod set; thence North (N 0° 00' 00" E) three hundred six and thirty-seven hundredths (306.37) feet to a 5/8 inch re-rod set; thence South eighty-nine degrees forty-four minutes twenty-four seconds West (\$ 89° 44' 24" W), through a 5/8 inch rerod set at six hundred ninety-nine and sixteen hundredths (699.16) feet, seven hundred twenty-nine and sixteen hundredths (729.16) feet to the place of beginning containing five and zero thousandths (5.000) acres, more or less, subject to legal highways and all easements and restrictions of record.
