



DESCRIPTION

Scale:

Being a part of the west half of the west half of the Southwest quarter of Section 24, T-4-S, R-4-E, and part of the Southeast quarter of Section 23, T-4-S, R-4-E, Salem Township, Auglaize County, Ohio and more particularly described as follows:

BEGINNING at an iron pin found in a monument box at the southeast corner of said Southeast quarter of said Section 23; thence N 89°12'27" W (basis of bearing - calculated) with the south line of said Southeast quarter (also the centerline of I.O.O.F. Rd.), 76.72 feet to a PK nail and shinner set at the intersection of said south line and centerline with the centerline of State Route 66 (Station 1154+08.06 on said centerline of State Route 66); thence N 18°35'39" W with said centerline of said State Route 66 (passing through a PK nail set at Station 1168+00.00), 2,821.02 feet to a PK nail and shinner set at the intersection of said centerline with the north line of said Southeast quarter; thence S 89°08'07" E with said north line (passing through a capped 5/8 inch rebar set at 58.33 feet), 1,021.81 feet to a capped 5/8 inch rebar set at the northeast corner of said Southeast quarter; thence S 88042'49" E with the north line of the Southwest quarter of Section 24, Salem Towsnhip, 332.22 feet to a point; thence S 00°59'38" W, 664.73 feet to a point; thence S 88045'02" E, 332.05 feet to a point on the east line of the west half of the west half of said Southwest quarter; thence S 01°00'27" W with said east line (passing through a capped 5/8 inch rebar set at 1,066.74 feet and at 1,977.05 feet), 1,993.55 feet to a PK nail and shinner set at the southeast corner of said west half of said west half of said Southwest quarter; thence N 88°51'43" W with the south line of said Southwest quarter (also the centerline of I.O.O.F. Rd.), 663.11 feet to the PLACE OF BEGINNING containing 68.988 acres more or less and subject to all highway and other legal easements of record. 33.539 acres being in the Southeast quarter of Section 23 and 35.449 acres being in the southwest quarter of Section 24. Road right-of-way occupies 4.140 acres Being part of Parcel J 27-024-005-00 and part of J 27-023-009-00. Deed Reference: Volume 236, Page 3.
