Being the east half of the northwest quarter of the northwest quarter of the Southwest quarter of Section 24, T-4-S, R-4-E, Salem Township, Auglaize County, Ohio and more particularly described as follows:

Commencing at an iron pin found in a monument box at the southeast corner of said Southwest quarter of said Section 24; thence N 88°51'43" W (basis of bearing) with the south line of said Southwest quarter (also the centerline of I.O.O.F.
