## DESCRIPTION

Being a part of the southwest quarter of Section 3, T-7-S, R-4-E, German Township, Auglaize County, Ohio and more particularly described as follows:

Commencing at a monument box found at the southwest corner of said Section 3 and the centerline of Lock Two Road; thence S 89 degrees 45' 05" E, along the South line of the southwest quarter and the centerline of said Lock Two Road, for a distance of 651.67 feet to a point; thence N 00 degrees 30' 57" W, for a distance of 849.50 feet to a point; thence N 89 degrees 38' 04" W, for a distance of 187.43 feet to a 5/8" re-rod w/cap (found); thence N 00 degrees 21' 56" E (passing through a 5/8" re-rod w/cap found at a distance of 231.32 feet) for a total distance of 463.82 feet to a 5/8" re-rod w/cap (set) at the northwest corner of that parcel evidenced by OR V. 93, P. 734,replacing a missing called for re-rod, said point being the **PLACE OF BEGINNING**, for the parcel herein described;

thence, N 22 degrees 02' 37" W, for a distance of 262.00 feet, to a 5/8" re-rod w/cap (set);

thence, N 67 degrees 57' 23" E, (passing through a 5/8" re-rod w/cap set on the westerly right-of-way line of CR 66-A, at a distance of 148.86 feet) for a total distance of 178.86 feet to a cotton gin spindle (set) in the centerline of said CR 66-A;

thence, S 22 degrees 02' 37" E, along said centerline of CR 66-A, (passing through a railroad spike found at a distance of 59.25 feet) for a total distance of 335.75 feet to the northeast corner of that parcel evidenced by OR V. 93, P. 734;

thence, N 89 degrees 38' 04" W, along the northerly line of the aforesaid referenced parcel (passing through a p-k nail found 1" deep at a distance of 0.30 feet and a 5/8" re-rod w/cap set on the westerly right-of-way line of CR 66-A at a distance of 32.45 feet) for a total distance of 193.47 feet to the **PLACE OF BEGINNING**, containing therein 1.227 acres, of which 0.227 acres is road right-of-way.
