

LEGAL DESCRIPTION

Being a part of the northeast quarter of Section 12, T-5-S, R-4-E, Noble Township, Auglaize County, Ohio and more particularly described as follows:

Commencing at a monument box (found) marking the location of the southwest corner of the northeast quarter of said Section 12 and the centerline of St. Marys-Kossuth Road; thence, N 89 degrees 46' 10" E along the South line of the northeast quarter of said Section 12 and the centerline of St. Marys-Kossuth Road, for a distance of 50.00 feet to a cotton gin spindle (set), said spindle being the **POINT OF BEGINNING** for the tract herein described;

thence, N 00 degrees 11' 35" E and parallel with the westerly line of the aforesaid northwest quarter, for a distance of 535.79 feet to a 4" steel post (found);

thence, N 25 degrees 21' 50" E for a distance of 9.42 feet to a 4" steel post (found);

thence, N 39 degrees 34' 50" E for a distance of 119.94 feet to a 4" steel post (found);

thence, N 63 degrees 14' 55" E for a distance of 35.75 feet to a 4" steel post (found);

thence, N 89 degrees 12' 45" E for a distance of 163.71 feet to a 4" steel post (found)

thence, S 19 degrees 15' 10" E for a distance of 86.34 feet to a 4" steel post (found);

thence, S 08 degrees 03' 00" E for a distance of 93.08 feet to a 1" iron pipe w/cap #6177 (found);

thence, N 89 degrees 29' 50" E for a distance of 806.69 feet to a 1" iron pipe w/cap #6177 (found);

thence, S 01 degrees 26' 00" W for a distance of 23.12 feet to a 5/8" re-rod w/cap (set);

thence, S 89 degrees 29' 50" W for a distance of 806.19 feet to a 5/8" re-rod w/cap (set);

thence, S 00 degrees 11' 35" W and parallel with the westerly line of the northwest quarter of Section 12, (passing through a 5/8" re-rod w/cap set on the northerly right-of-way line of St. Marys-Kossuth Road at a distance of 437.02 feet) for a total distance of 457.02 feet to a cotton gin spindle (set) on the South line of the northeast quarter of Section 12 and the centerline of St. Marys-Kossuth Road;

thence, S 89 degrees 46' 10" W along the aforesaid South line and centerline, for a distance of 317.77 feet to the **POINT OF BEGINNING**, containing therein 5.000 acres, of which 0.145 acres is road right-of-way and subject to all legal highways and easements of record at the time of recording of this instrument.
