LEGAL DESCRIPTION

Being a part of the southwest quarter of Section 20, T-7-S, R-4-E, Jackson Township, Auglaize County, Ohio and more particularly described as follows:

Commencing at the southwest corner of the southwest quarter of Section 20 and the centerline intersection of SR 119 and SR 364; thence, N 00 degrees 10' 35" E along the centerline of SR 364 and the West line of the southwest quarter of said Section 20, for a distance of 1875.34 feet to a cotton gin spindle (set), said spindle being the POINT OF BEGINNING, for the tract herein described;

thence, continuing along the aforesaid centerline and West line, N 00 degrees 10' 35"\$\for a distance of 788.17 feet to a p-k nail marking the location of the West quarter corner of said Section 20;

thence, N 89 degrees 52' 04" E along the North line of the northwest quarter of said Section 20 (passing through a 5/8" re-rod w/cap set for reference at a distance of 30.00 feet) for a total distance of 667.22 feet to a 5/8" re-rod w/cap (set);

thence, S 00 degrees 08' 26" W, for a distance of 788.36 feet to a 5/8" re-rod w/cap (set);

thence, S 89 degrees 53' 04" W (passing through at 5/8" re-rod w/cap set for reference at a distance of 637.71 feet) for a total distance of 667.71 feet to the POINT OF BEGINNING, Save and except the following parcel previously transferred by Deed Volume 257, Page 72 and more particularly described as follows:

Beginning at the northwest corner of the northwest quarter of the southwest quarter of Section 20, Town 7 South, Range 4 East; thence East along the half Section line a distance of 330 feet to a point; thence South parallel with the west section line of said Section 20 a distance of 660 feet to a point; thence west parallel with the half Section line a distance of 330 feet to a point in the West Section line of said Section 20; thence North along the West Section line of said Section 20, a distance of 660 feet to the place of beginning containing therein 5 acres. Containing in all after the aforesaid exception 7.078 acres, of which 0.081 acres is road right-of-way. Prepared by James M.
